Dismisses petition pleading to declare Tamnar line as illegal, null & void

PANAJI: The High Court of Bombay At Goa has dismissed petition pleading to declare Tamnar power transmission line as illegal, null and void. The High Court while dismissing the petition observed that 'Project is in public interest'.

The petitioners argued before the high court that the Supreme Court's ruling and the Central

Empowered Committee's (CEC) recommendations are in conflict with the planned 400 kV line route between Xeldem and Mapusa. They claimed that the work is being done in defiance of the Supreme Court, the CEC's recommendations, and the lack of authorized alignment lines. They added that, other from the current 220kV route, the project has no authority to access their properties at

Sexual harassment: Margao Adv detained

MARGAO: A lawyer from Margao named Adv Pritesh Prabhu has been detained by the Fatorda Police in relation to accusations made by two female lawyers that he allegedly outraged their modesty. The Fatorda Police filed two separate FIRs against the suspects in response to the complaints.

A female complainant claimed in the initial initial Information Report (FIR) that Pritesh had sexually



touched her while she was seated on a bench in the Margao Court of Judicial Magistrate First Class. The female complainant

in the second complaint claimed that the accused had inappropriately touched her. The event happened at the JMFC, Margao corridor.

Pritesh was previously detained by the Margao Police on suspicion of following a female attorney. The Margao Police then sent a female PSI and policeman to the accused's Davorlim home in response to the complaint.

The story took a turn when Pritesh's father, Adv Jayant Prabhu, killed himself and accused the woman PSI for being impolite during the search in his suicide note.

Mysuru: The Mysuru land authority at the centre of a financial and political storm - involving Chief Minister Siddaramaiah and alleged losses of ₹ 45 crore to the state - has received an offer of restitution from his wife, the urban development body's Commissioner, AN Raghunandan said. "I am in possession of a letter written by Siddaramaiah's wife regarding her intention to return 14 plots (of land). The Chief Minister's son, Yatindra Siddaramaiah, came to our office and delivered the letter. We will take legal advice for the next step..." he told reporters in Mysuru. Mr Raghunandan also confirmed anticorruption officials from

the city's Lokayukta branch had written seeking cooperation in its inquiry into the charges against the Chief Minister.He said the Mysuru Urban Development Authority, or MUDA, "will cooperate with the investigation". The Enforcement Directorate, however, have not reached out as yet, Mr Raghunandan said. The ED, a federal agency, has filed a money laundering case against Siddaramaiah. There have also been calls for the CBI, another federal agency, to investigate charges against the Chief Minister, but that appears unlikely now given the Karnataka government has withdrawn general consent for its operations in the state.

Matrimonial scams on rise; SP **CvberCrime warns Goans**

PANAJI: Goa residents have been forewarned by the Goa Police Cyber Crime Branch about an increase in marriage scams that prey on single women.

Rahul Gupta, Superintendent of Police (SP) Cyber Crime, alerted the public-especially single women-about the dangers of strangers pretending to be NRIs and attempting to buddy them on social media.



"The scammers specifically target unmarried women, claiming to be NRIs," the SP stated. They might ask you to marry them on Instagram or Facebook,

where they will friend you. The offer can be enticing, and the single woman might fall victim to it.

The scammer will say that he is traveling to India to

present gifts or to submit an official proposal. However, he might phone from an airport, claiming to be in need of money and acting as though he was caught by the police. He might ask the woman to assist him. A lady who is emotionally involved might eventually send the money.

"Avoid falling into such traps. SP Gupta advised, "One should always be cautious and avoid sending money to such fraudsters."

MLA Lobo says if South Goans do not want sunburn, it should not be imposed upon them

PANAJI: Tourism Minister Rohan Khaunte warned that unless the Sunburn organizers secure proper land to stage the event, with the required NOC for the same, the tourism department will not provide any authorization.

According to Khaunte, the organisers of Sunburn had proposed to hold the event in South Goa approximately five months prior, but they were lacking the necessary land for the location.

"Unless Sunburn organisers have land to host event with proper NOC, tourism dept will not grant any permission,"



said Tourism Minister Rohan Khaunte

Khaunte also said that almost 5 months back Sunburn organizers had submitted proposal to host event in South; but they had no land; no fresh proposal is moved to tourism dept so far.

"If they get all the required permissions, we will process their request," stated Khaunte.

Michael Lobo, the MLA constituency, the majority



of Goans are unwilling to tolerate Sunburn.

He remembered that the festival was originally hosted in Candolim and then moved to Vagator, which he thought was a suitable venue. In order to determine the optimal location for Sunburn-one with all the amenities required-he recommended that the government consult with officials.

PMO asks Goa govt to look into Smart City works mismanagement

PANAJI: The Goa Forward Party brought up concerns about the mishandling of Smart City projects in the capital city, and the Ministry of Housing and Urban Affairs (MoHUA) has requested that the State government investigate these matters.

Vijai Sardesai, the president of the Goa Forward Party and a member of parliament, wrote a letter to the prime minister's office (PMO) in New Delhi on June 12 of this year, accusing the office of corruption and ordering subpar work.

The letter also called for a thorough audit of the Panjim Smart City projects, covering financial, quality, and safety aspects.



In his letter, Sardesai said that the unplanned and chaotic building activity that was occurring while Panaji was being turned into a Smart City was the reason for the city's degradation. The Panaji locals were experiencing constant hardship due to the scenario. Sardesai had said that the project's implementation had been plagued by numerous problems, despite a significant funding allocation of almost Rs 1,200 crore, which had left the locals feeling deeply disappointed, irritated, and outraged.

VELSAO: Panic swept through the village of Velsao, particularly in the Dando area, after the South Western Railways announced the temporary closure of the railway crossing gate.





Bengaluru: The Karnataka High Court on Monday stayed investigation against Union Finance Minister Nirmala Sitharaman and others over alleged irregularities concerning the now scrapped electoral bond scheme. Justice M Nagaprasanna passed the interim order on a petition filed by BJP leader Nalin Kumar Kateel challenging the FIR in which he has been named as an accused. The matter will be next heard on October 22. A case was registered on Saturday against Sitharaman and others on the directions of a special court here, following a complaint relating to the scheme. According to police, the FIR was registered

under Bharatiya Nyaya Sanhita sections 384 (punishment for extortion), 120B (criminal conspiracy) and 34 (acts done by several persons in furtherance of common intention) against Sitharaman, Enforcement Directorate officials, and office-bearers of the BJP at state and national level. BJP Karnataka chief B Y Vijayendra has also been named in the FIR.

The complaint was lodged by Adarsh R lyer, Co-President of 'Janaadhikaara Sangharsha Parishath' (JSP), who alleged that the accused "committed extortion under the guise and garb of electoral bonds and benefitted to the tune of 8,000 and more crore of rupees."

Coldplay Concert Ticket Scalping Fiasco Sparks Huge Backlash

Controversies surrounding tickets for major international musical or sporting events are not new.

Mumbai: British rock band Coldplay's upcoming tour of India has triggered a police investigation and dismayed fans after scalpers bought up cheap tickets to resell online for more than ₹ 83000 a piece Thousands of music fans tried and failed to buy tickets for three concerts scheduled in the financial hub Mumbai next January, sold by the popular Indian online ticket portal BookMyShow. All three shows sold out in minutes, and those who missed out were infuriated when they saw tickets worth ₹ 6,000appear on resale websites at vastly inflated prices.



Ashwin, and Akash Deep picked two wickets each and Jadeja added one to his kitty, to complete 300 Test wickets.
