# **VELINGKAR GETS HC REPRIEVE**

HC says no need to arrest if he co-operates with the investigation To appear before Bicholim police by 5 pm today for questioning The matter was posted for further hearing on Oct 15

PORVORIM: In a major relief to absconding ex-Goa RSS chief Subhash Velingkar, the Bombay High Court at Goa has allowed Velingkar to appear before the Bicholim police by 5 pm today for questioning in an FIR registered against him for making a derogatory remark against St Francis Xavier and hurting religious sentiments.

High Court was hearing an anticipatory bail application of Velingkar, who expressed his willingness to be part of the investigation, provided the police assured that there would be no arrest.

Bicholim police in their submission said that it is



unlikely that he would be arrested if he cooperated in the probe.

Velingkar's move seeking anticipatory bail came two days after the Panaji Additional Sessions Court dismissed his previous anticipatory bail application.

Advocate Amit Palekar speaking to reporters after the hearing said that whether police forgot to take steps after non-

compliance notice or there were deliberate lapses still remains unanswered.

"IO should have made an application before the Court to seek arrest for failure to appear for probe," said Palekar. "Matter has been kept for Oct 15 seeking investigation report from IO; Velingkar's counsel made a categorical statement of surrender, which was the only option; the peaceful atmosphere is fostered through HC's order today,' said Adv Vaz. Since October 1, Velingkar has been avoiding appearing before the investigating officer at the **Bicholim Police Station** over his contentious "DNA test" of St. Francis Xavier relics. In accordance with Section 35(3) of the BNSS, the police had sent him three notifications to appear before the investigating officer.

He received notices for the first time on October 5, the second time on October 6, and the third time on October 8, but all attempts to locate and deliver the notices to him were unsuccessful. The police have put notices on his home's main door after **CONTD TO PAGE 04..**

# MMC Crackdown on Illegal Shops in New Vaddem: Chairperson Borker Warns of Strict Action

VASCO: In a surprise drive conducted on Thursday, the Mormugao Municipal Council (MMC) led by Chairperson Girish Borker discovered that most of the shops in New Vaddem were operating without valid trade licences and other necessary approvals. The council has issued a stern warning, threatening to seal the shops within three days if they fail to comply with the licensing

norms.

Chairperson Borker, visibly shocked by the situation, stated, "We started our drive from Shantinagar, and within just ten minutes, we realized that none of the shops had a valid trade licence. What's more alarming is that even the landlords renting out these shops have no lease agreements, leading to significant revenue leakage for the MMC." Borker further



emphasized the gravity of the issue, pointing out that many shop owners were unaware of the basic requirements for running a business. "One vendor who has been operating for over five years asked me what a trade licence was and what the formality required to obtain one. This just goes to show how much revenue has been lost by MMC over the years."


As the drive progressed, several shopkeepers began shutting their shops and fleeing the area. Borker issued a firm warning: "The vendors must take our drives seriously because we will take strict action. This is not about stopping anyone from doing business; it's about ensuring they operate legally. We have already served notices, and any failure to comply will result in the sealing of these establishments."

Borker also highlighted the need for landlords to pay their dues. "Landlords leasing shops have to pay MMC charges, and we are trying to cover the revenue leakage with such drives. We've noticed several illegalities, and now that we've uncovered them, we won't spare anyone.

# Cong demands probe by retired judge into communal tensions

Kawthankar says Jairam Ramesh, MP has reiterated his demand

**PANAJI:** In a letter to Governor P S Sreedharan Pillai, the Opposition Congress Party demanded the immediate removal of the Pramod Sawant-led government and the creation of an inquiry panel led by a retired High Court judge to look into recent communal incidents in the State.

The vice-president of the Goa Pradesh Congress Committee (GPCC), Sunil Kawthankar, wrote a letter to the governor claiming that communal conflicts have harmed people and the state's social fabric.

Kawthankar said that Jairam Ramesh, Member of Parliament former Union Minister and charge of Communication All India Congress Committee has reiterated his demand.

"The problem has gotten worse due to the government's inaction. Chief Minister Pramod Sawant's administration



had failed to safeguard the people and uphold law and order, and if it remained in office, the state would become much more unstable," said Kawthankar

In light of the Sawant government's collusion with those responsible for the state's heightened intercommunal tensions and its willful inaction in addressing the law and order crisis, Kawathankar urged the Governor to use constitutional authority to recommend the Sawant government's removal from office.

He described the situation in Goa as unusual, saying that long-standing communal harmony is being methodically destroyed in order to achieve limited political objectives.

In light of the severe public backlash against the BJP government in the state over a range of issues, including rampant corruption, environmental destruction caused by massive illegal hill cutting, and the destruction of forested land to make way for mega real estate projects that threaten Goa's identity, culture, and heritage, Kawthankar urged the governor to form a probe panel headed by a retired High Court judge to investigate the sudden escalation of communal tensions.

As per Kawthankar's assertion, the fallout resulted from the Goa Police's purposeful failure to act on the spur of the moment in response to former RSS Goa Prant chief Subhash Velingkar's remarks about St. Francis Xavier allegedly hurting religious sentiments. Other BJP leaders also made similar remarks in public.

"This begs the question of whether these occurrences were planned to happen in a particular order in order to sow religious strife in the otherwise calm state of Goa and deflect attention away from the real problems that the state is facing," he added.

**PANAJI:** Pope Francis has appointed Cardinal Filipe Neri Ferrão, the Archbishop of Goa and President of the CCBI to a committee tasked with drafting the final document for the Synod on Synodality. This Synod began its second session in the Vatican on October 2 and will conclude on October 27, 2024. Along with Cardinal Ferrão, Pope Francis also appointed Sister Leticia Salazar from California and Fr. Giuseppe Bonfrate from Rome. Among the elected members are Catherine Clifford, a theologian from St. Paul University in Ottawa; Cardinal Fridolin Ambongo, the president of the Symposium of Episcopal Conferences of Africa and

Madagascar; Bishop Shane Mackinlay of Sandhurst, Australia; Cardinal Luis José Rueda Aparicio of Bogota, Columbia; Cardinal Jean-Marc Aveline of Marseille; Father **Clarence Davedassan** of Malaysia; and Bishop Mounir Khairallah, a Maronite Bishop.Ex officio members include Cardinal Jean-Claude Hollerich of Luxembourg, Cardinal Mario Grech, Secretary-General of the Synod of Bishops, Msgr. Riccardo Battocchio, and Jesuit Father Giacomo Costa. Cardinal Ferrão, who was made a Cardinal by Pope Francis on August 27, 2022, has served as the President of the CCBI since his election at the 31st Plenary Assembly in 2019 and was re-elected during the 33rd Assembly in 2022.

#### **3 Ugandan nationals arrested for illegal overstay in Goa**

**ANJUNA:** Three Ugandan nationals living in Goa without proper travel documentation were taken into custody by the Anjuna Police following a special operation.

# Submit tenant verification or face strict action: Goa CM's warning

**PANAJI:** Chief Minister Pramod Sawant today has warned public against failure to verify tenants while stating that strict action will be initiated against house owners.

"People who fail to furnish details of tenants will have to pay Rs 10k fine; I still urge people to willingly visit police station & comply with tenant verification process within next 3-4 days; failure to comply will attract strict action," said Sawant

He further said that if someone is found staying in a house without verification, the house owner will have to pay a fine of Rs 10,000.

"It has been made compulsory. Therefore, house owners must fill out tenant verification forms and submit them to the respective police stations." he said

The CM stated that contractors of industrial units will also need to be registered with the Labour Department, and if they fail to do so, they will not be allowed to work in the state.

"The contractors will have to provide a list of workers to the concerned police station. It has been observed that migrants are involved in most crimes," he said.



# Delhi CM's Residence Sealed? Atishi's Belongings 'Forcibly Removed', LG's Office Says She 'Trespassed'

The Delhi CMO in a statement alleged that Lieutenant-Governor VK Saxena wants to allocate the residence to "some important BJP leader"

New Delhi: The Delhi Chief Minister's Office (CMO) on Wednesday alleged that Atishi's official residence at Civil Lines was forcibly vacated at the behest of the BJP, claiming that Lieutenant-Governor V.K. Saxena wants to allocate it to a leader from the saffron party.

The belongings of Delhi Chief Minister Atishi were removed from the residence, which was previously occupied by her predecessor, Arvind Kejriwal, according to the CMO statement.

Meanwhile, there was no immediate response to these allegations from the LG's office or the BJP.

AAP leader Atishi had moved her belongings to the Delhi Chief Minister's residence at 6 Flagstaff Road in Civil Lines on Monday. The bungalow had been occupied for over nine years by fellow party leader and former Delhi CM Arvind



Kejriwal, who vacated it after resigning as Chief Minister.

Atishi illegally occupied bungalow: L-G Office Meanwhile, source in the Lieutenant Governor's Office told India Today that AAP's claims about the bungalow being the "official residence of the Delhi Chief Minister" were incorrect. The source noted that bungalow in question is not designated as the Chief Minister's house and can be allocated to anyone.

The source also stated that Atishi had illegally occupied the property, as it was not officially designated for her.

"Atishi trespassed at 6, Flagstaff Road. The bungalow was never designated for her occupancy, despite her request to the Public Works Department (PWD)," the source said, further adding, "If someone trespasses onto a property, the owner is entitled to take action."

BJP Tring To Capture CM's residence: AAP Earlier today, AAP Rajya Sabha MP Sanjay Singh alleged that the bungalow had not yet been officially allotted to Atishi and accused the BJP of trying to "usurp" it. He claimed that a camp office of the Chief Minister located on the bungalow premises had also been vacated. Singh also dismissed the BJP's allegation that Kejriwal did not vacate the CM residence after stepping down.

"As a CM, Atishi had to occupy the residence. But it has not been allocated to Atishi. She made it a camp office and started meetings, then they ousted the staff. The BJP is now trying to capture the CM residence as they are not winning the elections," Singh told the media during a briefing.

Calling it "cheap politics," AAP chief national spokesperson Priyanka Kakkar said that the Lieutenant-Governor needs to understand that winning an election is a "basic requirement" for anyone to stay at the Chief Minister's residence.
