Ailing senior citizens duped by woman at Quepem

QUEPEM: A woman connected to an NGO that works for the care of older persons in Curchorem is accused of defrauding a number of elderly people, many of whom were patients, out of crores of rupees in a startling fraud case.

By gaining access to her victims' SIM cards, taking money out of their fixed deposits, and even snatching gold jewelry from their bank vaults, the accused is accused of abusing their confidence.

The woman is the subject of a complaint filed



at the Curchorem Police Station. Locals, however, are furious over what they perceive to be the police's tardiness in filing the complaint.

Residents rushed the Curchorem Police Station on Tuesday night, demanding an immediate inquiry and justice for the victims, frustrated by the lack of action.

stringent oversight of organizations that assist senior folks have been brought up by the occurrence. The unfortunate elderly have been reassured by police that they are looking into the situation and would deal with the offender appropriately.

Criminal Suleman used multiple bank accounts in his girlfriends' names: SP

PANAJI: Siddhique, also known as Suleiman Mohammad Khan, was arrested by the Special Investigation Team (SIT) on November 12 for land grabbing cases from Hubballi. According to the Goa police on Tuesday, he used the SIM cards and bank accounts of most of the 35 women he befriended to stay hidden and carry out illicit activities.

"Suleiman was wanted in three SIT cases for land grabbing and was declared proclaimed offender in two cases filed at Anjuna and Mapusa Police Stations,"



stated Rahul Gupta, Superintendent of Police (SP), Crime Branch, during a press conference.

According to the SP, Suleiman has been the subject of seven cases filed at the Mapusa, Valpoi, and Anjuna police stations.

In addition, he has four FIRs filed against him in Hyderabad, three in Pune, and one in Delhi, where the Delhi Court has deemed him a proclaimed

criminal.

According to Gupta,
Suleiman had been
detained in a number
of prisons throughout
the nation, including
Cherlapally (Hyderabad),
Tihar, Yerawada, and
Colvale. Six properties in
all—two in Tivim, three in
Gaulim Mola, and one in
Mapusa—are at issue in
the cases filed against him
in SIT.

According to the SP, police are also investigating four additional houses where he may be engaged. According to the police officer, his personal possessions in Belgaum and Mapusa would be attached.

Tawadkar rejected the idea of competitiveness in response to rumors of a confrontation with Minister Govind Gaude, equating disagreements with those within families or communities. "I have different ideas and opinions than other party members. There is no competition, and they are working to the best of their skills," he stated.

PIL filed against Sunburn festival in Dhargalim

PANAJI: A Dhargalim resident is attempting to get permissions for the Sunburn festival in Goa revoked by filing a Public Interest Litigation (PIL) in the Bombay High Court in Goa.

Bharat Bagkar claimed in his appeal that Dhargalim is undertaking infrastructure development with the goal of achieving general socio-economic prosperity.

He expressed worries that issues including drug and alcohol abuse, excessive noise, and light pollution could result from the festival's proposed new location in Dhargalim, which was publicized on its social media page.

In addition, he claimed that the festival organizers had errors in their tax payments and arrears and had not



followed earlier High Court orders.

According to the petition, "there is no quick alternative but to approach the Court through this PIL given the larger public interest at risk due to the Sunburn

Festival 2024." Additionally, it asks the Court to rescind or annul the festival's licenses. As an alternative, the petitioner proposed relocating the event to a private place outside of Dhargalim, ideally somewhere that promotes travel. In addition, the petitioner requested that the Court halt the festival's ticket sales and authorization while the case is pending.

GCCI seeks VAT reform ior liquor dealers

PANAJI: To avoid more taxes on incentives and discounts that booze merchants receive, the Goa Chamber of Commerce and Industry (GCCI) has urged the government to alter the Goa VAT law.

Rohan Bhandare, the chair of the **GCCI Taxation** Committee, expressed concerns about the Tax Department's interpretation of the legislation in a letter to the State Commissioner for Commercial Taxes.

According to Bhandare, booze



dealers buy products from vendors and claim a credit for input taxes on the taxes they pay. Suppliers frequently provide discounts or incentives, including cash refunds or sales promotions. "The Tax Department has reversed input tax credits from liquor dealers' balances and demanded interest on these amounts because it believes that these incentives are taxable in their hands," Bhandare

ESA Central team to visit Goa for verification Team Goemkarponn

PANAJI: Beginning on November 26, the expert committee appointed by the Union Ministry for Environment, Forests, and Climate Change (MoEF&CC) to review the State governments' opinions and objections regarding Western Ghats **Eco-Sensitive Areas** (ESA) will travel to Goa for four days in order to verify the State's submission on the ground.

In its submission to the Union Ministry, the Goa government suggested removing 21 villages off the ESA list.

This proposal was based on the findings of a



seven-member committee constituted by the State and led by Dr. Devendra Pandey, the former director general of the Forest Survey of India.

The committee has suggested that 87 communities be classified as ESA since they satisfy the Ministry's

The committee, led by former Forest Director-General Sanjay Kumar, will work with the state government to determine whether its requests to exclude villages designated as ESA are warranted.

The Environment Minister suggested that they visit the State and

the ESA committee had certain concerns during the State response.

Twelve villages are from Sattari, five are from Dharbandora, three are from Sanguem, and one is from Canacona taluka, according to the government's proposal.

Out of the 87 villages that were suggested under the ESA categories, 51 are located in Sattari taluka, 23 in Sanguem, 8 in Dharbandora, 4 in Canacona, and 1 in Ponda. A total of 1,247 square kilometers of Goa are suggested for ESA classification. Once finalised, villages marked as ESA



Modi, who arrived in the Brazilian city on Sunday after concluding a two-day trip to Nigeria, met Lula on the sidelines of the G20 Summit here and complimented him on various efforts of Brazil during their G20 Presidency.

"We took stock of the full range of bilateral ties between our nations and reaffirmed our commitment to improving cooperation in sectors like energy, biofuels, defence, agriculture and more," Modi said in a post on X after talks with Lula.

Brazil is hosting the 19th G20 Summit. India is part of the G20 Troika along with Brazil and South Africa.

"What Kind Of Doctors...": Brother Of MBBS Student Who Died Due To Ragging

Fifteen senior students have been arrested in connection with the ragging case. They face the charge of culpable homicide not amounting to murder, among other sections

Ahmedabad: Days after an 18-year-old MBBS student at a Gujarat medical college died, allegedly after he was made to stand for hours during a ragging session, his family has questioned what kind of doctors such seniors would become.

Anil Methaniya, a first-year student of GMERS Medical College and Hospital in Dharpur Patan this year, was among several first-year students who were allegedly harassed by seniors on Saturday night during "introduction". "Introduction" or "intro" is a word frequently used for ragging activities on residential campuses.



After standing for hours at a stretch, Anil collapsed and became unconscious. He was hospitalised and he told police that he was made to stand for three hours. He died soon after. Fifteen senior students have been arrested in this connection. They face the charge of culpable homicide not amounting to murder, among other sections.



India Urges COP29 To Ground Final Decision On Equity, Climate Justice, As Talks Enter Crunch Time

India also firmly highlighted how the developed countries have resorted to unilateral measures hindering climate actions in the Global South.

New Delhi: As COP29 entered its crunch time of negotiations in Baku, India stressed that the final outcome must be grounded in equity and climate justice. Countries are negotiating to finalise a finance deal to replace the previous \$100 billion target set in 2009.

Delivering India's national statement at the year's biggest annual climate summit in Azerbaijan, Union Minister of State for Environment, Forest and Climate Change, Kirti Vardhan Singh, said COP29 is historic because the decisions made here will enable those in the Global South not only to take ambitious mitigation action but also to adapt to climate change. "The outcome must be clear and ambitious and consider the evolving

needs and priorities of the developing countries, and their commitment to sustainable development and eradication of poverty," he emphasised.

India has pushed for at least \$1.3 trillion every year until 2030 to be mobilised by the developed countries through grants, concessional finance and non-debt-inducing support, as part of the new climate finance target. Many developing countries, including India, have consistently highlighted the huge financial burden faced by these nations in mitigating climate change, as well as dealing with loss and damages. India emphasised that in such emergent situations, there is no option but to break all barriers to the flow of technology, finances and capacity to the Global South.

"Rama Krishna Hari": Supriya Sule On Cousin Ajit Pawar's Bitcoin Row Remark

Mumbai: The Maharashtra government will order a probe and truth will come out, Deputy Chief Minister Ajit Pawar said today when asked about allegations of bitcoin fraud against his cousin and Lok Sabha MP Supriya Sule. "An inquiry will be done and the truth will come in front of the people," Mr Pawar, who is contesting the Assembly polls from Baramati, said this morning.

"Whatever audio clip is



being shown, I just know that I have worked with both of them. One of them is my sister and the other is someone with whom I have worked a lot. The audio clip has their voices, I can figure out from their tone. An inquiry will be done and everything will be clear," he added.

The remarks play

out against the rivalry between the two camps of NCP -- one led by veteran politician and party founder Sharad Pawar and Ms Sule and the other by Ajit Pawar.

An Ajit Pawar-led mutiny split the NCP in 2023, following which the junior Pawar joined the BJP-Shiv Sena government in the state. This election is also a fight between two factions of NCP to prove who has the people's support.

Rally Protesting Against Reimposition Of AFSPA Stopped In Manipur

Imphal: Defying curfew, members of various civil society organisations on Tuesday held a rally in Manipur's Imphal West district to protest against the reimposition of AFSPA in parts of the northeastern state.

The procession was, however, stopped by the police at Keisampat junction as it defied curfew orders clamped in view of recent violence in the northeastern state.

Members of All Manipur United Clubs Organisation (AMUCO), Poirei Leimarol Meira



Paibi Apunba Manipur and other local bodies took out the rally from the Kwakeithel area in the district and covered around 3.5 km before being stopped, a protester said.

"We strongly condemn the reimposition of AFSPA in areas under six police stations. A firing incident occurred in Jiribam district just a few days after AFSPA was reimposed in Jiribam," he said.

He referred to the Jiribam firing incident which left one person dead and another injured on Sunday night.

The incident occurred

during a clash between security forces and a mob that was vandalising properties in the Babupara area of Jiribam.

The AFSPA gives armed forces operating in disturbed areas sweeping powers to search, arrest and open fire if they deem it necessary for the "maintenance of public order".

The Centre has recently reimposed the Armed Forces (Special Powers) Act in Manipur's six police station areas, including the violence-hit Jiribam.

India Beat Japan, Set Up Women's Asian Champions Trophy Title Clash Against China

New Delhi: Defending champions India continued their unbeaten run and defeated Japan 2-0 to enter the final of the women's Asian Champions Trophy hockey tournament in Rajgir on Tuesday. Vice-captain Navneet Kaur converted a penalty stroke in the 48th minute while Lalaremsiami struck from field play in the 56th minute for India, who had plenty of scoring chances including 13 penalty corners. India will face China, whom they defeated in the league stages, in the final on Wednesday. Earlier, China beat Malaysia 3-1 in the first semifinal.

Malaysia will take on Japan in the third-fourth place match, while Korea finished fifth after beating



Thailand 3-0 in the fifthsixth place classification match.

The Indians continued their attacking game and put on early pressure on the Japanese defence, just like the last league game.

The play was mostly inside the Japanese half

as the Indian defence was hardly tested.

India had the first shot at the goal inside the initial five minute. Skipper Salima Tete's attempt was thwarted by Japanse goalkeeper Yu Kudo. The Indians repeatedly penetrated the Japanese citadel and in the process secured two penalty corners in a span of two minutes but Kudo was alert under the bar to deny Navneet Kaur and Deepika.

Three minutes into the second quarter, India secured three back-to-back penalty corners but failed to find the back of the net. It was raining penalty corners for the hosts as they got back-to-back set pieces in the 21st minute but Kudo produced a brilliant save with her fully-stretched right leg to deny Deepika again.

In the 24th minute, India earned a penalty corner followed by another in the next minute but failed to get past Japanese goalkeeper Kudo, as they also lacked in execution.

While the Indian skipper's presence would be vital for the series opener in Australia, former cricketer Surinder Khanna conveyed heartfelt wishes to Rohit but also emphasised the importance of joining the squad for the high-stakes encounter.

Rohit had earlier communicated to the BCCI, regarding his unavailability for the first Test due to the birth of the second child. With, Rohit certainly unavailable, vice-captain Jasprit Bumrah is poised to don the captaincy responsibility for India.

"First of all, I want to congratulate Rohit and his family on the birth of their



baby boy and wish them all the luck. But now the family is complete - a son and a daughter - so Rohit should go and play the Test match.
