# Goa CM meets Governor Pillai Amid **Cabinet Reshuffle Speculations**

**PANAJI:** Amid growing rumors of a Cabinet reshuffle, Goa Chief Minister Pramod Sawant met with Goa Governor PS Sreedharan Pillai at the Raj Bhavan on Wednesday. Sources close to the development revealed that the

discussion primarily revolved around Goa University and plans to relocate four government colleges to its campus. Sources suggest that the key agenda of the meeting was the government's plan to shift four government-run colleges-Architecture, Fine Arts, Pharmacy, and



Music-onto the Goa University campus. This proposal is seen as part of a larger strategy to consolidate the state's higher education system, aiming to enhance both academic offerings and infrastructure under a unified campus. The timing of this meeting is noteworthy, as it coincides with widespread speculation about a potential reshuffle of CM Sawant's Cabinet.

**MAPUSA:** In the vibrant streets of Mapusa, a series of crackdowns by the Food and Drug Administration (FDA) has left nine food stalls near Alankar Theater in shambles as their unhygienic conditions and blatant disregard for food safety standards came under scrutiny. These raids were a part of a broader initiative aimed at ensuring that food vendors in public spaces adhere to minimum hygiene and safety standards. FDA officials conducted thorough inspections, revealing a dismal state of affairs at these stalls. They found that food preparation and storage practices were grossly inadequate, with raw materials not handled properly and excessive use of food coloring being common.

**NEW VADDEM:** In a shocking hit-and-run incident, a pedestrian sustained injuries after being struck by a speeding vehicle at New Vaddem. The Vasco Police have registered a case against the accused driver, who fled the scene without offering medical assistance to the victim. According to the police report, the incident occurred at around 8:40 PM on the slope

leading towards the New Vaddem residential area. The accused, identified as Romeo Carvalho, a resident of New Vaddem, was driving a WagonR car in a rash and negligent manner, endangering public safety. While proceeding from GSL Vaddem towards New Vaddem, Carvalho allegedly hit pedestrian Manoj Sharma, who was walking on the left side of the road. Following the collision, the driver reportedly fled the scene



with the vehicle, failing to provide medical aid or inform the authorities about the accident. As a result, Sharma fell to the ground and suffered injuries.Upon receiving the complaint from Head Constable Suresh Dassar (HCB No. 4642) of Vasco

Police Station, an offence was registered against Carvalho under Sections 281 and 125(b) of the Bharatiya Nyaya Sanhita (BNS) and Sections 134(a) & (b) of the Motor Vehicles Act.

The Vasco Police have launched an investigation into the incident, with Head Constable Suresh Dassar leading the case. Further action is expected as authorities work towards identifying and apprehending the accused driver.



### **Household Items Gutted** in Fire at Vaddem

VADDEM: A major fire broke out at a house in Vaddem, opposite Pai Hospital, leaving household items completely gutted. The house, belonging to Sadanand Poojari, was engulfed in flames while the owner was away. Fortunately, no casualties or injuries were reported.

The cause of the fire remains unknown, but the damage was extensive. Alert neighbors noticed thick black smoke billowing from the house and immediately informed Poojari and the Vasco Fire Station. Firefighters arrived promptly at the scene and managed to douse the flames, preventing the fire from spreading to nearby

houses. Speaking to reporters, Poojari expressed his shock over the incident.

"I have been living here for many years, and I never expected something like this to happen. In fact, I had closed everything properly, including the cooking gas connection, before leaving for my native place this morning. I left around 9:30 AM, but then I got a call that thick smoke was coming from my house. I rushed back only to find my home on fire," he said.

He further added, "I am not sure what caused the fire-whether it was a short circuit or something else. My clothes, household appliances, bed, and other belongings have been completely destroyed."

### **UP native arrested with ganja worth Rs 5 lakhs**

**SIOLIM:** A narcotics raid took place in Siolim, Bardez, Goa, on April 1, 2025, between 00:35 hrs and 03:40 hrs, based on reliable information. During the operation, Sonu Yadav, a 29-yearold from Nauwaboh, Islamabad Post,

Madanpur, Deoria, Uttar Pradesh, was arrested for possessing 5,010 grams of suspected Ganja, valued at around Rs. 5,00,000.

The narcotics were discovered on Yadav's white Honda Activa scooter (Registration No. GA-07-M-7636). As a result, the Anjuna Police



Station filed an FIR (No. 57/2025) under Section 20(b)(ii)(B) of the NDPS Act, 1985. Yadav was taken into custody and

He had clarified that any reshuffle would be announced a day before it takes place to allow the media to inform the public. Responding to reports suggesting a reshuffle might occur in April, Sawant had urged caution, advising not to trust unverified dates. "Someone comes up with

that the reshuffle will happen when it's deemed appropriate. The CM further had explained that the reshuffle will be carefully analyzed to benefit both the Bharatiya Janata Party (BJP) and the government, with a focus on securing their position in the next state elections, due in 2027. Currently, the 12-member cabinet led by Sawant includes 11 members from the BJP and one from its ally, the Maharashtrawadi Gomantak Party (MGP). Goa's assembly allows for a maximum of 12 ministers. The BJP, which holds 28 seats in the 40-member legislative assembly, along with two MGP members and three Independents, enjoys a strong majority. Sawant's remarks suggest that any reshuffle would be a strategic move to maintain the party's dominance ahead of the upcoming election.

filed a petition against the Electricity Department, claiming the department acted unfairly by cutting fibre optic cables. However, the association decided to withdraw the petition after settling the matter, which was communicated to Justices Bharati Dangre and Nivedita Mehta during the final hearing. As a result, the court allowed the withdrawal and dismissed the case. The association argued

that despite following proper procedures, the Electricity Department acted arbitrarily. They pointed out that their application for the Right of Way (RoW), submitted on November 22, 2023, to the Department of Information Technology, was still pending. The group had requested permission to deploy fibre networks across seven regions of Goa but had not received approval, despite multiple attempts to follow

up.The petition also referenced the National RoW Policy, which takes effect on January 1, 2025, and requires states like Goa to enable the use of electricity poles for fibre optic deployments. Although the association claimed it was in compliance with this policy, it still faced interruptions, including cable cutting by the **Electricity Department** before any official decision had been made.

It also emphasizes the importance of fire prevention, preparedness, and response to minimize fire-related risks.



Trump Tariff Announcement: The US President also announced a 20 per cent levy on imports from the European Union and 10 per cent from the UK - two of the main trade partners and allies of the United States.

New Delhi: In a move aimed at rebalancing international trade, **US President Donald** Trump has announced a comprehensive package of tariffs targeting major trade partners. At the center of this strategy is a 26% "discounted reciprocal tariff" on India, part of a broader effort to address long-standing trade imbalances.

These tariffs, set to take effect in early April, reflect a broader shift in US trade policy, emphasizing what Trump terms "reciprocity."



The tariffs announced include a 26% duty on Indian imports and a 34% duty on those from China. These rates are described as "discounted" because they were set based on what Trump referred to

as half the amount that these countries charge on US imports. For instance, Trump referenced India's high auto tariffs when explaining the measure, noting a previous conversation with Prime

Minister Narendra Modi where he expressed concerns about unfair trade practices.

In addition to these tariffs, the European Union will face a 20% levy on its imports, while the UK will incur a 10% tariff. Japan is set to encounter a 24% tariff on its exports to the US. These tariffs will be imposed on top of a baseline 10% import duty on all foreign goods entering the US. The baseline tariff starts on April 5, with the specific country tariffs following on April 9.



### **Centre Analyzes Consequences of US Tariffs; Deems Them 'Mixed Bag'**

According to the official, the universal 10 per cent tariffs will come into effect on all imports into the US from April 5 and the remaining 16 per cent from April 10

New Delhi: In a bold move aimed at redressing trade imbalances, the United States has imposed a 26% reciprocal tariff on Indian goods. This significant development has prompted the Indian Commerce Ministry to scrutinize the potential effects on the nation's economy. The tariffs are part of a broader strategy by President Donald Trump to tackle longstanding trade disparities with countries like India, known for imposing substantial tariffs on American products.

The United States will begin enforcing a universal 10% tariff on all imports starting April 5, with an additional 16% levied from April 10. This dual-pronged approach reflects the administration's commitment to rebalancing its trade relationships globally.

Meanwhile, India is actively engaged in negotiations with the United States to finalize the first phase of a bilateral trade agreement by September-October this year. This ongoing dialogue aims to address mutual trade concerns and could potentially

mitigate the impact of the tariffs.

**President Trump's** announcement highlighted the high tariffs India imposes on American goods, citing a 52% rate. In response, the US has implemented a "discounted" reciprocal tariff of 26%. Trump also underscored the significance of April 2, 2025, as a landmark day for American industry and economic resurgence, emphasizing the need for fair trade practices. The chart presented during the announcement visually underscored the disparity in tariffs between the two nations.

Despite these developments, the Indian Commerce Ministry views the situation as a "mixed bag" rather than a setback. This perspective is informed by President Trump's personal relationship with Prime Minister Narendra Modi, which could offer an avenue for diplomatic solutions.

Trump's emphasis on maintaining friendly relations with India's leader while pressing for equitable trade practices adds a nuanced dimension to the situation.

### Jaishankar Criticizes Yunus's 'Cherry-**Picking' of Northeast Connectivity**

Muhammad Yunus, during his recent four-day visit to China, remarked that India's Northeast was "landlocked" and had "no way to reach out to the ocean."

New Delhi: The recent visit of Bangladesh's Chief Adviser Muhammad Yunus to China has ignited a diplomatic firestorm after he described India's Northeast as "landlocked" and positioned Bangladesh as the "guardian of ocean access" for the region.

This provocative statement has drawn sharp rebukes from Indian leaders, including **External Affairs Minister** S Jaishankar, who highlighted India's pivotal role in the Bay of Bengal Initiative for Multi-Sectoral



**Technical and Economic** Cooperation (BIMSTEC).

Muhammad Yunus, during his China visit, accentuated the strategic potential of Bangladesh's maritime access for India's Northeast. This, coupled with his encouragement

#### Supreme Court Upholds Cancellation of Teachers' Appointments in West Bengal The Mamata Banerjee government had challenged the Calcutta High Court order in the Supreme Court

New Delhi: In a dramatic turn of events, the Mamata Banerjee government in West Bengal has suffered a significant setback as the Supreme Court upheld a Calcutta High Court order, voiding the appointments of over 25,000 teachers and non-teaching staff. This decision not only highlights the alleged recruitment fraud that marred the hiring process but also marks a broader

issue of governmental accountability.

The controversy centers around the 2016 recruitment process by the West Bengal School Service Commission, which was found to be tainted by manipulation and fraud. Despite the state government's efforts to challenge the High Court ruling, the Supreme Court saw no reason to interfere, affirming that the



entire selection process lacked credibility. At the heart of the controversy are "supernumerary posts"

created by the state government, which allowed more appointment letters to be issued than there were vacant positions. This

irregularity has been linked to a broader recruitment scam that has implicated several top Trinamool Congress leaders, including former Education Minister Partha Chatterjee. To rectify the situation,

the state government has been directed to conduct a fresh recruitment process within three months. Candidates who succeed in this new selection process will

not be required to return their previous salaries. while those who fail must repay. An exception has been made for persons with disabilities, who can continue in their current roles.

Senior BJP leader Amit Malviva has termed the Supreme Court verdict as a "crushing defeat" for Mamata Banerjee, emphasizing the need for accountability.
