**DHARGAL:** In a shocking incident early Monday morning, a 17-year-old student from Dhargalim, Pernem, sustained serious burn injuries in a suspected acid attack at the local bus stand. Police are investigating whether a personal dispute linked to a love affair may have motivated the assault.

The attack took place around 7:50 a.m. as Rishab Shetye, a higher secondary school student in Mapusa, waited for his bus. According to police, an unidentified person on a two-wheeler approached and hurled acid from a bucket onto the teenager before fleeing the scene. Eyewitnesses described Shetye running along the

# Acid at a Bus Stop: Is This the New Face of Goa? blame. Goa has always

he acid attack on a 17-year-old girl at a bus stop in Panaji has left Goa stunned and exposed. A crime so grotesque, so terrifying in its intent and brazenness, has forced the state to confront an uncomfortable truth: the Goa we knew is slipping away.

The peaceful, safe, closeknit society that defined our identity is under threat. And one cannot ignore the growing chorus—from citizens and even Chief Minister Dr Pramod Sawant himself that the unchecked rise in migration is playing a role in this transformation. Over the years, Goa has seen a significant influx of people from other states come in search of honest work, others unfortunately bringing with them the chaos and criminal tendencies from places they've fled.

Dr. Sawant has on record voiced concerns about the need to monitor and regulate this inflow. His statements, though politically cautious, have pointed to a growing problem: lack of background checks, poor verification of tenants and labourers, and rising strain on infrastructure and law enforcement.

The result? A state that once prided itself on safety and community trust is now seeing rising cases of violent crimes, murders, assaults, sexual violence, and now, acid attacks.

Goans are beginning to feel like strangers in their own land. Local youth complain of job losses, residents speak of cultural dilution, and women say they no longer feel safe walking alone. And while it is important not to paint all migrants with a broad brush, it is equally irresponsible to ignore the patterns emerging. The real question is not whether migration is happening, it is what the state is doing about it. So far, the answer seems to be: not much. There is no mandatory tenant verification in xenophobia or blanket

welcomed people from other parts of India and the world. But there must be rules, and more importantly, enforcement. We need a state-wide Migrant **Registration and Verification** System, where landlords are legally required to submit details of tenants to local police.

Labour contractors must be registered, and workers must be issued ID cards verified through Aadhaar or other government documentation.

Police patrolling and surveillance must be increased, particularly in fast-growing urban and semi-urban pockets like Mapusa, Ponda, and Margao. CCTV coverage must be expanded, and most importantly, law enforcement officers need to be trained to deal with a diverse and growing population.

The judiciary must fasttrack heinous crimes like acid attacks, and survivors must receive immediate medical and psychological support.

This cannot be left to political speeches alone. The Chief Minister must now move from observation to action. His past warnings must become policies. And these policies must be implemented with seriousness, not tokenism.

Goa is at a tipping point. We can either keep looking the other way and allow this quiet takeover of our culture, security, and peace or we can act now to preserve

## **An Heinous Crime in Kolkata** and the Irresponsible **Statements from TMC**

West Bengal's capital, Kolkata, is once again in the news-and once again, for all the wrong reasons. The Mamata Banerjeeled Trinamool Congress (TMC)

government is drawing heavy flak, not only for the crime itself but more so for the irresponsible and misogynistic statements made by its own leaders. "Didi"—as Mamata Banerjee is fondly called—is expected to rein in the motormouths within her party ranks.

Last Wednesday, Kolkata witnessed an alleged heinous crime. A 24-year-old law student from a city-based law college was reportedly sexually assaulted. In a rare instance of swift action, Kolkata Police arrested four accused soon after the incident came to light. However, even before the public could fully process the horror of the crime, some leaders from the ruling party grabbed the limelight for all the wrong reasons. Their controversial, regressive, and misogynistic remarks have rightfully drawn nationwide outrage.

TMC MP Kalyan Banerjee shocked the nation on Friday by stating-according to reports across national dailies-that police cannot be deployed in every college, and that male students should protect "their female colleagues." The Honourable MP further said that women should also stand up against such crimes. If that wasn't enough, came another appalling remark—this time from Madan Mitra, TMC MLA from Kamarhati. In a statement that can only be described as victim-blaming, he suggested the incident could have been avoided had the victim not gone alone or taken friends along. According to him, informing someone or being accompanied by two friends might have prevented the crime.

These statements were not just insensitive-they were insulting. They undermined the pain of the survivor and attempted to shift the blame from the perpetrators to the victim. The nation expected outrage and solidarity from its elected representatives; instead, it got regressive advice and thinly veiled justifications. Facing intense backlash, the TMC quickly issued an "official statement" distancing itself from the remarks. It termed the comments as "personal opinions" of the leaders and not reflective of the party's stance. But by then, the damage had already been done. The words had been spoken. The wound was inflicted. The larger question is: Why does this happen every time a heinous crime of this nature occurs? Why do political leaders, across party lines, make remarks that are not only in poor taste but often shame the victim?

We've seen this pattern too many times. Each incident of sexual assault triggers three predictable reactions. First, the national conversation around "women are unsafe everywhere" gains fresh traction. While this debate is necessary, it often fades out without producing any concrete solutions. The truth is, it is men's responsibility to ensure that women feel safe-at home, in public spaces, and everywhere in between. Our society cannot progress unless women feel secure, empowered, and respected. Second, the political blame game begins. Opposition parties slam the ruling party, highlighting the failing law and order situation. Politicians parade before the media, expressing scripted outrage, while little changes on the ground. And third, some politicians-either out of ignorance or callousness-shame the victim, delivering unsolicited lectures that fuel public anger and cause further trauma to the survivor.

system in place. There is no comprehensive migrant worker database. Many panchayats remain clueless about who is living within their jurisdictions. Police stations, under-resourced and overworked, rarely follow up on new arrivals unless a crime is committed. The solution does not lie

what remains of our identity. Being open-hearted does not mean being unprotected. Tolerance does not mean lawlessness.

This acid attack must not be dismissed as just another crime. It must be the final straw that forces our state to reimagine how we manage migration, police our communities, and safeguard our people. Goa can still remain a land of susegadbut only if we defend it.

# Sardesai Vows to Raise Mandrem's CRZ, **Tuem Hospital Concerns in Assembly**

**MANDREM:** Goa Forward Party chief and Fatorda MLA Vijai Sardesai has assured residents of Mandrem that he will take up critical local issues in the upcoming Assembly session, including Coastal Regulation Zone (CRZ) restrictions affecting

homes and the prolonged non-operational status of Tuem Hospital.

Speaking at a meeting at the Mandrem Zilla Panchayat hall, Sardesai criticised local representatives for failing to address these concerns in the Assembly, saying that neglect has left vital problems

unsolved. The session was organised to listen to complaints from Mandrem and Pernem residents.

Goa Forward general secretary Durgadas Kamat, North Goa district president Deepak Kalangutkar, and former Mandrem sarpanch Prashant Bala Naik joined Sardesai at the meeting.

Locals expressed worry over plans to widen the MDR road to 25 metres, arguing it would threaten many homes and businesses, and demanded justice on the issue. They also questioned why Tuem Hospital, which has been ready for seven years, remains closed.

# **11-Year-Old Boy Dies** from Electric Shock in Canacona

CANACONA: An 11-yearold boy, identified as Samesh Gauder, tragically lost his life after suffering an electric shock in the Bhatpal area of Canacona.

The incident occurred on the afternoon of June 28, when the young boy was reportedly using a mosquito bat near an extension board inside his room.

According to family members, Samesh accidentally received an electric shock, which caused him to lose consciousness.

He was immediately rushed to the Community Health Centre (CHC) in Canacona, where he was later declared dead.

Local police conducted an inquiry at the health center and confirmed the cause of death through a post-mortem examination. The Police Surgeon

reported that the boy died from electrocution,



with burns found on the medical aspect of his right thigh (the probable point of entry for the electric current) and smaller burns on the left foot (possible exit wounds). The shock led to fatal cardiac arrhythmia.

The body of the deceased was handed over to the family after the post-mortem for disposal according to religious rites.

Police Sub-Inspector (PSI) Ajith Velip of the Canacona Police Station is handling the investigation and has urged locals to exercise caution when using electrical appliances.

was disposed of before it could be seized, officers managed to find the SIM card, which will be key evidence in the investigation.



## **Chorao Ferry Remains Stuck Underwater for a Week**

CHORAO: A week after it partially sank at the Chorao Island ferry ramp, the vessel Betim is still lying submerged, throwing daily travel plans of islanders and commuters into disarray. The prolonged disruption has raised questions over how soon the ferry can be retrieved and whether it will remain usable once salvaged. Officials have

promised that normal operations will resume once the submerged vessel is removed and the route is made safe for other ferries. But repeated attempts to lift the sunken ferry have failed so far.

**River Navigation** Department (RND) Minister Subhash Phal Dessai admitted on Saturday that an earlier recovery operation was unsuccessful. "We tried once, but could not get



it out. Further efforts are underway and we will ensure the ferry is recovered intact-it won't go to waste," he told reporters.

Vikramsinh N Raje Bhosale, Director of the River Navigation Department, said workers

attempted another lift on Saturday but the vessel could not be raised. "We've now secured a pontoon to the ferry. We're hoping it can be lifted by tomorrow," he said.

The Betim ferry began sinking early on Monday, June 23, after one of its tanks reportedly flooded. Three parked motorcycles also went down with it, though they were recovered later the same day.

# Senior Citizen Duped of ₹3.13 Lakh in Cyber Fraud; One Arrested in Kolkata

**OLD GOA:** In a significant breakthrough in a cyber fraud case, Old Goa Police have arrested a man from Kolkata for allegedly duping a 71-year-old retired individual of ₹3.13 lakh through a phishing scam conducted over WhatsApp.

The case was registered on June 5 under Crime No. 81/2025 at Old Goa Police Station under Section 319(2) of the Bharatiya Nyaya Sanhita and Section 66 of the Information Technology Act, following a complaint by the senior citizen residing in St. Cruz, Tiswadi.

According to police, the victim received a video call on May 30, allegedly from a person claiming to be "Mr. Dipak Agarwal" of



the Bank of Baroda. The caller falsely offered a free shopping benefit on the victim's credit card as a gesture for retired bank employees. During the call, the victim was tricked into sharing his CVV and OTP details, which led to an unauthorized withdrawal of ₹3,13,000 from his bank account.

An investigation team led by the Superintendent of Police, North Goa, Rahul Gupta, launched a detailed technical analysis. This led to the identification of the accused, Suman Ghughu, a resident of Kolkata, West Bengal. Authorities revealed that the stolen funds had been swiftly transferred across multiple bank accounts in an attempt to conceal the trail.

Following requisite permissions from district authorities, a team from Old Goa Police proceeded to West Bengal and placed the accused under surveillance for two days. On June 27, with assistance from Netaji Nagar Police Station in Kolkata, Ghughu was apprehended. During initial questioning, he reportedly gave evasive answers and denied any involvement, despite digital evidence suggesting

otherwise.

The accused was presented before the A.C.J.M. Court in Alipore, which granted a three-day transit remand. He has since been brought to Goa and formally arrested at Old Goa Police Station after following due legal procedures and Supreme Court guidelines.

He is scheduled to be produced before the Hon'ble JMFC Court, Merces, on June 30.Police confirmed that further investigation is underway to trace the origin of the fraudulent network, recover the defrauded amount, and identify other members possibly involved in the scam.

## Youth Arrested in Goa for Alleged Rape of Minor

SANKHALI: A 22-yearold man, Sachin Uallappa Kholkar, a resident of Karapur Sankhali, Goa, has been arrested and taken into police custody on charges of allegedly raping a minor girl.

The complaint was filed by the victim's mother, aged 40, also a resident of Sankhali.

According to the brief facts provided, Kholkar allegedly developed a relationship with the complainant's minor daughter between August 27, 2022, and June 28, 2025.

It is further alleged that he exploited her on the pretext of marriage and engaged in sexual intercourse with her on several occasions, constituting the offense of rape.

The alleged incidents took place at a location identified as C/o Hassan



Jahangir, Lalbag Kajuwada Karapur Tisk Sankhali Goa.

The accused has been booked under Section 376 of the Indian Penal Code (IPC), which deals with punishment for rape.

Additionally, charges have been pressed under Sections 4, 6, 8, and 12 of the Protection of Children from Sexual Offences (POCSO) Act, which provides a stringent legal framework for protecting children from sexual abuse, and Section 8(2) of the Goa Children's Act, 2003.

Sachin Kholkar is currently lodged in police custody, and further investigation into the matter is underway.

## AAP Seeks Accountability Over Irregularities in Invest Goa 2024

**PANAJI:** The Aam Aadmi Party (AAP) has raised serious concerns over the findings of the Comptroller and Auditor General (CAG), which highlight financial and procedural irregularities in the organization of the Invest Goa 2024 summit.

In a statement issued, Engr. Roque Virgilio Mascarenhas, Vice President of AAP Goa and leader from Curtorim, called for institutional accountability and



governance.

He warned that when public money is misused or spent without proper scrutiny, it is ultimately the citizens of Goa who pay the price.

Calling the CAG's findings deeply concerning, he demanded that the Government of Goa initiate an independent inquiry into all financial approvals linked to the summit, fix individual accountability, and implement audit recommendations without delay. He also urged the government to ensure greater transparency in future public-private projects.

# Fatal Accident in Valpoi: Reckless Truck Driver Causes Fatality and Injuries

VALPOI: A tragic road accident on June 27, 2025, near Ganapati Temple, Redye Ghat, Valpoi, has left one person dead and another injured after a reckless Eicher truck driver collided with an Activa scooter.

The incident occurred around 8:15 PM when Kanifnath, a 39-year-old resident of Mawadikade, Pathar, Purandar, Pune, Maharashtra, was driving an Eicher truck (registration number MH-12-WX-2564) in a negligent and dangerous manner.

As he approached the Redye Ghat area, Kanifnath reportedly changed lanes without warning, striking an Activa scooter traveling in the opposite direction.

The collision caused serious injuries to both the rider and the pillion rider of the scooter, who were identified as Ganesh Betkiker and Varsha Pokle.

Varsha, the 36-year-old pillion rider, was tragically declared dead on arrival by medical officials at the



Community Health Centre (CHC) Valpoi. Ganesh, the scooter rider, suffered significant injuries but is currently receiving treatment.

Shockingly, the truck driver fled the scene without providing assistance or notifying authorities or emergency services. The police were immediately alerted, and an offense was registered under multiple sections, including Section 134(a) (b) of the Motor Vehicle Act, 1988, for failure to stop and assist after an accident, among other charges.

Raghunath, an Assistant Sub-Inspector at Valpoi Police Station, filed the case (M.V. Accident No. 14/2025) on June 29, 2025.

The investigation is currently underway, led by PSI Kushali Naik of Valpoi Police Station. Authorities are working to trace the truck driver, Kanifnath, who has yet to be apprehended.

## **Tragic Drowning Incident in Mandrem River Claims Life of Local Security Guard**

MANDREM: A tragic drowning incident occurred this evening at Mandrem River, claiming the life of Ramesh Khathayat, a 30-year-old security guard working at Mandrem Beach Resort. According to local sources, Khathayat, originally from Nepal, had been fishing in the river along with his friend, Nabajyoti Bore. The two were using a small boat when the strong currents caused the boat to capsize, throwing them both into the water.

While Bore managed to find safety by holding onto nearby trees and bushes, Khathayat was unable to find support and was swept away by the current. Locals quickly alerted the Fire Brigade, who were able to recover the body of Khathayat after an intense search.

The deceased's body was subsequently sent to the Goa Medical College Morgue in Bambolim for preservation and further medical legal procedures. A case has been registered at Mandrem Police Station under UD No. 32/2025, and



**CANACONA:** A 47 year old woman from Agonda ended her life by jumping into a Well late in Canacona.



An e-passport is a modern version of the traditional passport, equipped with an embedded electronic chip that stores the passport holder's biometric and personal information. The chip is embedded in the back cover of the passport and includes details such as the individual's name, passport number, date

of birth, photograph, and fingerprints. It also includes a Radio Frequency Identification (RFID) chip and antenna, enabling contactless reading by immigration systems. A distinctive

gold-colored symbol on the front cover helps distinguish e-passports from standard ones Applying

for an e-passport involves a few simple steps. Applicants must visit the official Passport Seva website, sign up or log in to their account, and fill in the e-passport application.

After selecting an appointment slot at the nearest Passport Seva Kendra (PSK) or Post Office Passport Seva Kendra (POPSK), applicants need to pay the required fee and appear at the center for biometric data capture and document verification.

E-passports come with several advantages. The embedded chip ensures enhanced security and significantly reduces the risk of tampering or counterfeiting.

Speaking to reporters, the victim's father said the family was at a complete loss to explain the

"The family has provided some leads to the police. The motive could be related to a relationship angle," Arlekar stated. India and the US are set to finalise a trade deal within a week, with mutual concessions on agriculture and automobiles, sources have said.

New Delhi: India and the United States are on the verge of concluding a significant bilateral trade agreement, with sources indicating that the deal could be finalised within the coming week. The breakthrough comes as the clock ticks down on a 90-day tariff reprieve announced by former **US President Donald** Trump — set to expire on July 9 - prompting a renewed urgency in trade negotiations.

According to senior officials, both nations have agreed on key concessions in sectors such as agriculture and automobiles. Rajesh Agarwal, Special Secretary in India's Department of Commerce and currently leading a high-level delegation in



Washington, confirmed that India would continue to safeguard its core agricultural interests, particularly regarding staples like rice, wheat, fruits, and millets.

On the US side, the Biden administration (carrying forward Trump's pending frameworks) is poised to offer market access for Indian auto components, which would enjoy reduced tariffs under the new arrangement. In return, India will provide incentives for select American vehicles, including models from electric vehicle giant Tesla, and allow greater access for certain American auto parts and spares.

"These are sensitive areas for both economies, but we've found common ground," said Agarwal, speaking to reporters during ongoing talks with officials from the United States Trade Representative (USTR) office.

The looming July 9 deadline, set by Trump as part of a previous executive order dubbed "Liberation Day," has added significant pressure to seal deals. Trump had previously stated that countries failing to reach trade agreements with the US would face heightened tariffs. In a recent interview with Fox News, he warned that trade penalties would be reinstated if no deals materialised.

"We'll look at how a country treats us — are they good, are they not so good — some countries we don't care, we'll just send a high number out," Trump said in a taped segment aired Sunday.

### Indian Officials Extend US Visit to Finalize Trade Deal Ahead of July 9 Tariff Deadline

■ The bilateral talks, which were originally scheduled to wrap up on June 27, continued for an extra day as both sides sought to bridge key differences

New Delhi: Indian officials have extended their stay in Washington as last-minute negotiations intensify to secure a trade agreement with the United States before a critical July 9 deadline. The talks, originally scheduled to conclude on June 27, continued into an extra day as both sides pushed to resolve lingering issues, according to sources familiar with the discussions.

The extension has fueled speculation that the two nations are close to finalizing an interim trade deal. Sources, who spoke on condition of anonymity due to the sensitive nature of the negotiations, told Bloomberg that the prolonged discussions signal meaningful progress. At the center of



the talks is a bid to avoid a renewed imposition of higher US tariffs on Indian exports. The 90day pause in these tariffs, granted earlier by the US, is set to expire on July 9, creating urgency for a resolution. One major sticking point remains the US push for India to allow imports of genetically modified (GM) agricultural products. Indian negotiators have firmly resisted the demand, citing risks to domestic agriculture and food security. India maintains that such a move could negatively impact its small and marginal farmers.

### 6 Feared Dead, 20 Injured in Massive Explosion and Fire at Telangana Chemical Factory

Telangana Chemical Factory Blast: The incident occurred at a chemical factory in the industrial area in Sangareddy district around 9 a.m.

**Telangana:** A devastating explosion rocked a chemical factory in the industrial hub of Pashamailaram in Telangana's Sangareddy district on Monday morning, leaving six workers feared dead and at least 20 others injured.

The blast occurred around 9 a.m. at the premises of Sigachi Industries, triggering a massive fire that engulfed large sections of the facility.

The Indian Navy's warship, INS Tabar, swiftly responded to a distress call from the vessel -MT Yi Cheng 6 – and launched a rescue and firefighting operation that is being hailed as a textbook example of

# **AB de Villiers Slams India's** Workload Management of Bumrah, **Cites Dale Steyn's Example**

AB de Villiers believes Jasprit Bumrah should have played all five Tests in the series against England, comparing his workload management to Dale Steyn.

New Delhi: Former South African skipper and IPL great AB de Villiers has criticised the Indian cricket team's approach to managing Jasprit Bumrah's workload, particularly during the ongoing highstakes Test series against England. According to de Villiers, Bumrah, currently regarded as the world's top bowler across all formats, should have featured in all five matches rather than being rested for preplanned games.

"Test cricket is the ultimate format," de Villiers remarked on his YouTube channel. "And this England series would have been the perfect stage to unleash Bumrah for all five Tests. You don't rest your best bowler when the stakes are this high."



De Villiers, who faced Bumrah in the twilight of his career, believes the Indian team should adopt a strategy similar to what South Africa once used with pace spearhead Dale Steyn. "With Dale, we made sure he was always available for the big Test series-against Australia, England, India, and sometimes New Zealand depending on the context.

He would skip T20s and less significant ODIs to be fresh for marquee Test matches," he said.

India is currently in the middle of a tough five-Test series for the Anderson-Tendulkar Trophy, and Bumrah's planned absence from two Tests, including the second one at Edgbaston, has sparked intense debate. Given the English conditions that suit his bowling style, many fans and analysts are questioning the rationale behind resting him. While de Villiers

acknowledged that medical advice could have played a role in the decision, he remained critical of how Bumrah's schedule has been handled. "Maybe the doctors or his surgeon advised against playing all five Tests, especially after his injury layoff," he said. "If that's the case, it's understandablebut from a cricketing standpoint, these are the moments you prepare for." The former Proteas captain underlined the importance of managing elite fast bowlers sensibly but also emphasized the significance of marquee series.

## **Ayush Shetty Clinches Maiden BWF World Tour Title at US Open; Tanvi Sharma Finishes Runner-Up**

New Delhi: India's young badminton star Ayush Shetty made headlines on Sunday by capturing his first-ever BWF World Tour title at the US Open Super 300, ending the country's title drought this season.

The 20-year-old produced a dominant performance in the men's singles final, defeating Canada's third seed Brian Yang in straight games, 21-18, 21-13, in just 47 minutes.

The victory capped off a remarkable week for Shetty, who also stunned top seed Chou Tien Chen in the semifinals with a gritty comeback win. This win marks Shetty's third triumph over Yang this year, following earlier victories at the Malaysia and Taipei Opens. Shetty, a bronze medallist at the 2023 Junior World
