# FDA Seizes 2.9 Tonnes of Unlabelled Food in Border Checks

PANAJI: The Directorate of Food and Drugs
Administration (FDA) conducted a late-night surveillance drive at
Goa's three State borders
– Patradevi, Keri and
Mollem – from 8 pm on
August 21 to 7 am on
August 22, targeting
interstate vehicles carrying food items.

During the operation, FDA officials detained 1,760 kg of unlabelled chicken and 500 kg of paneer at Keri, 700 kg of chicken from an unverified source at Mollem, and 10 kg of khoa at Patradevi, in the interest of public health.

Several food samples, including vegetables and fruits, were also collected for laboratory testing.

Officials said that while compliance had improved compared to previous inspections, efforts were being intensified to further scale up food safety standards.

The FDA team also sensitised food suppliers on legal requirements relating to labelling and transportation of food products. The drive was carried out under the leadership of FDA Director Shweta Dessai, with field teams deployed at all three border check-posts.



### SC Issues Fresh Guidelines on Stray Dogs: Vaccination, Release, Designated Feeding Zones

■ Court allows release of strays after sterilisation and vaccination, but bans feeding on streets

New Delhi: The Supreme Court on Friday modified its earlier directive on stray dogs, allowing their release after sterilisation and vaccination while tightening restrictions on public feeding. A threejudge bench of Justices Vikram Nath, Sandeep Mehta, and NV Anjaria stayed the August 11 order of the Pardiwalaled bench, which had barred the release of captured strays. The court clarified that sterilised and immunised dogs must be released back into the same locality, but those suffering from rabies or displaying aggressive behaviour would not be

The court further ruled that stray dogs cannot be fed on public roads, warning that those who violate the order will face legal action. Instead,



municipal bodies have been directed to create designated feeding areas within wards, taking into account the population and concentration of stray dogs. Notice boards will also be placed at these locations to make clear that feeding is permitted only in such zones.

In addition, the bench reiterated that no individual or organisation should obstruct sterilisation and vaccination drives by municipal authorities. It directed dog lovers and NGOs to deposit security amounts of ₹25,000 for individuals and ₹2 lakh

# Goa to Introduce QR-Based Tracking for Garbage Management

Panaji: Goa will soon roll out a QR-code-based digital tracking system to monitor garbage collection and disposal across municipalities, as part of its mission to become a model state in sustainable waste management.

Urban Development Minister Vishwajit Rane, who chaired a review meeting on Friday, said



the new system will bring transparency and accountability at every stage of waste handling. "Through QR-code based monitoring, every step of garbage collection — from households to final disposal — can be tracked in real time. This will not only enhance efficiency but also ensure accountability," Rane said.

Under the initiative, each household and collection point will be tagged with unique QR codes, enabling authorities to track whether waste has been collected, segregated into four categories, and

## How India's Russian Oil Buys Stabilise Global Markets And Why the West Quietly Benefits

New Delhi: External Affairs Minister S. Jaishankar, during his visit to Moscow this week, firmly defended India's continued imports of Russian crude, calling them a stabilising factor for global energy markets. Standing alongside Russian Foreign

Minister Sergey Lavrov, Jaishankar pushed back against Western criticism, noting that China — not India remains the largest buyer of Russian oil, while Europe continues to import Russian LNG in significant volumes.

# No Work, No Pay: Time to Make MPs Accountable

he recently concluded monsoon session of Parliament has once again highlighted the yawning gap between what citizens expect from their elected representatives and what they actually deliver.

Out of the 120 hours allocated for serious legislative business and debate, the Lok Sabha functioned for only 37 hours. That is just 31 per cent of the time.

The Rajya Sabha fared only slightly better at 41 hours, or 38 per cent. Together, the two Houses wasted more than 150 hours—time that should have been spent discussing bills, scrutinising government decisions, and addressing pressing national concerns.

The financial translation of this disruption is staggering: an estimated ₹204 crore of taxpayers' money was wasted. Yet, the MPs responsible for this dysfunction continue to draw full salaries, allowances, and perks without consequence. This is nothing short of a betrayal of the people.

Parliament is meant to be the crucible of democracy, where divergent views clash, consensus is built, and decisions that affect 1.4 billion citizens are made. Debate, dissent, and sharp questioning are not only legitimate but essential. But what unfolded during the session was not robust democratic exchange—it was orchestrated chaos.

Shouting matches, placard displays, and deliberate disruptions swallowed up valuable hours. What citizens saw was not lawmakers engaged in fierce but constructive debate, but politicians turning Parliament into a theatre of protest. Both the government and opposition are guilty. The ruling benches accuse the opposition of staging deliberate blockades; the opposition claims the government stonewalls every attempt at accountability. The outcome is the same: the public loses, while the MPs walk away unscathed.

The oft-repeated defence that disruptions are part of democratic functioning is deeply dishonest. Disruption, when used sparingly, may draw attention to urgent concerns. But when it becomes the norm rather than the

exception, it ceases to be a tool of democracy and instead becomes an instrument of democratic decay. A system in which weeks of scheduled debate are reduced to hours of slogans is not a functioning legislature; it is a mockery of the very idea of parliamentary democracy.

Citizens are left with no choice but to ask: why should we pay our MPs in full when they refuse to work in full?

In every other profession, "no work, no pay" is a simple and accepted principle.
An employee who fails to perform duties cannot expect a paycheck at the end of the month. Why then should Members of Parliament be exempt from this standard? If 70 per cent of the scheduled time is wasted, then 70 per cent of MPs' salaries for that session should be deducted.

The equation is both fair and necessary. Lawmakers

cannot pocket taxpayer money while simultaneously wasting taxpayer time. By linking pay directly to productivity, we can create incentives for MPs to prioritise debate over disruption.

The government and the presiding officers of both Houses must take the lead in reforming rules to enforce accountability. At present, MPs who indulge in disruption face little more than mild admonishments or, at worst, suspension for a day or two. These measures have lost their sting. What is required is a system of enforceable financial consequences. Salaries and allowances must be tied to the actual hours of functioning. Persistent disruptors must face cumulative deductions and eventual suspension.

Transparency is equally crucial. The productivity of each session should be published daily in a format that every citizen can easily understand: hours lost, questions asked, bills debated, and names of members responsible for obstruction. Let voters see clearly how their representatives are performing. It is important to emphasise that demanding accountability is not an attack on dissent. Healthy democracy requires strong opposition and uncomfortable questions.

But there is a difference between questioning and preventing questions, between opposing and obstructing. Citizens have the right to hear their representatives argue passionately on issues that affect their daily lives—rising prices, unemployment, education, healthcare, and national security. What they do not deserve is the sight of MPs shouting each other down while nothing is achieved.

The monsoon session stands as another reminder that conscience appeals alone are insufficient. Our lawmakers have shown time and again that they will not police themselves. It is now up to the system and ultimately the people—to enforce discipline. Linking salaries to productivity is the first step toward restoring dignity to Parliament. The people of India deserve a legislature that works as hard as they do. Until then, the message must be clear: no work, no pay.

## Will Margao Benefit from Digambar's Elevation?

whith the latest cabinet reshuffle, the Pramod Sawant government has finally inducted former Chief Minister Digambar Kamat into its council of ministers. Politically, the move is significant. It strengthens the BJP's numbers, consolidates its hold on defectors, and rewards a veteran who was once the Congress's tallest leader in Goa. But for the people of Margao, the city that has sent Kamat to the Assembly for three decades, the pressing question is whether this elevation will bring any real relief to their daily struggles.

Margao, despite being Goa's commercial capital, is also its most congested city. The once vibrant town square has given way to unregulated traffic, illegal parking, and chronic gridlock. Pedestrians navigate broken pavements, motorists crawl through bottlenecks, and residents see little evidence of long-term urban planning. Successive governments, and indeed successive tenures of Kamat himself, have promised solutions. Yet, Margao continues to choke under the weight of its own importance.

The most glaring symbol of this neglect is the Sonsodo garbage mess. Year after year, mountains of waste pile up, contracts are handed out, and temporary fixes are paraded as solutions. Despite crores being sanctioned, Sonsodo remains a festering wound. As minister, will Kamat finally muster the will and clout to resolve this embarrassment once and for all? Or will it continue to be treated as a problem too politically inconvenient to touch?


Equally shameful is the state of the Margao bus stand. For over two decades, promises of a modern transport hub have been recycled during every election. Instead, commuters are left with leaking sheds, poor facilities, and chaotic arrangements. Margao deserves a bus stand befitting its stature as South Goa's hub, yet the project has remained mired in files and announcements. With Kamat's return to power, will this long-pending demand finally be addressed, or will it be pushed aside yet again in favour of short-term optics?

Then there is the South Goa District Hospital, a facility that was meant to be the pride of the region. Instead, it has become a half-functional institution, lacking adequate specialists, equipment, and staff. For many Madgaonkars, it is a hospital in name alone, forcing them to travel to GMC Bambolim for serious treatment. If Kamat truly wishes to redeem his political legacy, ensuring that this hospital functions as it was envisioned must be at the top of his priorities

The irony is inescapable. Digambar Kamat has represented Margao since 1994, holding powerful portfolios and even serving as Chief Minister. Yet, the city remains in disrepair. His re-entry into the cabinet may help the BJP tighten its grip ahead of the 2027 polls, but unless he uses his influence to deliver on Margao's unresolved civic issues, the political reward will mean little for ordinary citizens.

It is easy to see why the BJP has welcomed him—he lends stature, weakens the opposition, and brings electoral arithmetic in South Goa under control. But politics cannot be only about strategy. It must also be about service.

## **HC Issues Notice on Goa Foundation Plea to Suspend Mining Operations**

PANAJI: The Goa Bench of the Bombay High Court has issued notice to the State government on a Public Interest Litigation (PIL) filed by the Goa Foundation seeking suspension of all mining operations in the state after the monsoon.

The PIL, heard by Justices Bharti Dangre and Nivedita Mehta, will be taken up for consideration of interim relief on September 18, 2025. The Goa Foundation has argued that mining in the state has recommenced without an effective regulatory framework, despite repeated assurances given by the government to Constitutional courts. The petition cites violations of the Supreme Court's



directions, the Mines and Minerals (Development and Regulation) Act, 1957, and Goa's own mining policies and rules. Raising concerns over past mismanagement, the NGO alleged that undue influence of private players on regulators had caused major losses to the exchequer and grave environmental damage. The PIL further stated that the Department of Mines & Geology lacks basic infrastructure, including laboratories, and depends solely on leaseholders' self-declarations of ore quantity and grade. Emphasising the Public Trust Doctrine, the Goa

Foundation pointed out that mineral resources belong collectively to the people and must be managed transparently to safeguard both present and future generations. The petition noted that the State could potentially earn over ₹87,000 crore from the auction of 12 mineral blocks — nearly four times its projected budget revenue for 2025–26 — and argued that funds should not be a hurdle in creating a robust regulatory system. As part of interim relief, the NGO has demanded round-theclock supervision of mining activity, establishment of an independent ore-grading laboratory, verification mechanisms for production and pricing data, and a grievance system for affected village populations.

## **Verification Rules**

PANAJI: The Goa government has circulated draft rules under the Goa (Verification of Tenants) Act, 2024, making tenant verification compulsory across the State, and has invited suggestions and objections from the public within 30 days.

The draft Goa (Verification of Tenants) Rules, 2025, mandate that landlords must confirm the identity of tenants by checking specified original documents and submit copies—either physically or digitally—to the nearest police station within 48 hours of renting out their premises.

In addition, landlords will be required to maintain a permanent register of tenants in the prescribed format.

## Goa Seeks Public Feedback on Draft Tenant AAP Goa Draws **DGP's Attention**

Over Growing Gun Culture in State

Panaji: The Aam Aadmi Party (AAP) Goa has sought an appointment with the Director General of Police (DGP) to discuss what it described as the "growing gun culture" and deteriorating law and order situation in the state.

In a letter addressed to the DGP, AAP Goa president Adv. Amit Palekar said the party was "deeply concerned over alarming incidents taking place one after another," citing the recent shootout at Mungul, an open gun firing at Marcaim, and the attack on a police officer. "These incidents, along with rising cases of thefts, assaults, and gang wars, have left citizens anxious



about their safety and shaken their confidence in the system. Urgent and visible steps must be taken to restore peace and law and order across the state," Palekar wrote. The party has requested the DGP to grant an appointment at the earliest to allow a delegation of AAP leaders to present their observations and suggestions.

He further said that police are seen conducting nakabandis only after crimes occur, while criminals roam freely at night attacking and robbing people.

Calling the situation "unacceptable and shameful", Alemao accused the government of being incapacitated and completely failing to protect its citizens.

### **Four Arrested in Fatorda Road Rage Assault Case**

Margao: Fatorda Police have arrested four persons in connection with a violent road rage incident that left two men injured near the Old Hospicio Hospital on Wednesday afternoon.

The complaint was lodged by Mohammad Rashid, a resident of Benaulim and native of Uttarakhand, who alleged that around 1:20 pm on August 20, he was assaulted following an argument over overtaking. According to police, the rider of a Hero Honda Passion motorcycle first abused Rashid



in filthy language and then attacked him with a screwdriver on his left arm.

When Rashid attempted to seek safety inside the Urban Health Centre, Fatorda, the accused allegedly regrouped with around 15 others, formed an unlawful assembly, and chased him. They are said to have assaulted him with kicks and even a fire extinguisher, causing

injuries. Rashid's brother, Mohammad Shavez, was also attacked and slapped during the incident.

## "Maharaja in Tariff": Trump's Trade Adviser Targets India Over Russian Oil Imports

■ Though the US imposed an additional 25 per cent tariff on India for its energy ties with Russia, it has not initiated similar actions against China, the largest buyer of Russian crude oil.

Washington: US
President Donald Trump's
trade adviser Peter
Navarro has launched
a sharp attack on India
for continuing its energy
trade with Russia, calling
New Delhi the "Maharaja
of tariffs" and accusing it
of running a "profiteering
scheme."

Speaking to reporters outside the White House, Navarro said he expects the punitive 50% tariffs on Indian imports—including an additional 25% levy tied to Russian oil purchases—to take effect on August 27.

"Prior to Russia's invasion of Ukraine in 2022, India bought virtually no Russian oil. Now, 35% of their needs are met by Russia. They don't need the oil. It's a refining profit-sharing scheme, a laundromat for the Kremlin," Navarro alleged. He argued that Indian refiners were buying discounted crude and exporting premium products to Europe, Africa,



and Asia, calling it "pure profiteering."

Navarro warned that the trade deficit and India's import of Russian crude were hurting American workers, claiming: "The money they get from us is used to buy Russian oil, which then funds arms that kill Ukrainians. US taxpayers end up footing the bill for more aid to Kyiv. That's insane."

India has pushed back strongly against the criticism. During his Moscow visit, External Affairs Minister S. Jaishankar said New Delhi was "perplexed" by Washington's stance, pointing out that the US itself had encouraged India to stabilize global energy markets, including through Russian oil purchases.

"We are a country where, actually, the Americans said for the last few years that we should do everything to stabilise the world energy markets, including buying oil from Russia," Jaishankar noted.

India's reliance on Russian crude has surged dramatically since sanctions were imposed on Moscow in 2022. From a mere 1.7% share of total imports in 2019-20, Russia now accounts for 35.1% of India's oil imports in 2024-25, making it New Delhi's top supplier. Moscow-based Kasatkin Consulting estimates that India now takes 37% of Russia's total oil exports.

Navarro also accused India of "cosying up" to Chinese President Xi Jinping, pointing to New Delhi's recent outreach to Beijing. His remarks came as India and China agreed to work toward resolving their long-standing border dispute after Chinese Foreign Minister Wang Yi's visit to New Delhi.

Beijing, in turn, sought to show solidarity with India against Washington's tariff moves. "China firmly stands with India to uphold the multilateral trading system and safeguard international fairness and justice," Chinese envoy Xu Feihong posted on X. Trump's decision to double tariffs on Indian goods to 50% has pushed New Delhi-Washington ties to a new low.

### Jaishankar in Moscow: Calls for Urgent Steps to Address India-Russia Trade Imbalance

■ During his Moscow visit, Mr S Jaishankar suggested ways to expand the trade relationship between the two countries to tackle the trade deficit. He said that the imbalance "needed to be addressed urgently."

Moscow: External Affairs Minister S. Jaishankar on Friday stressed the need to urgently tackle the growing trade imbalance between India and Russia, even as bilateral trade has surged more than fivefold in the past four years.

Speaking at the India-Russia Inter-Governmental Commission on Trade, Economic, Scientific, Technological and Cultural Cooperation (IRIGC-TEC) alongside Russia's First Deputy Prime Minister Denis Manturov, Jaishankar highlighted that India's imports, largely driven by discounted Russian crude oil, had created a sharp deficit.

"Over the last four years, our bilateral trade in goods has increased more than five-fold from



\$3 billion in 2021 to \$68 billion in 2024-25. However, the imbalance has widened from \$6.6 billion to \$58.9 billion about nine times higher. We need to address that urgently," Jaishankar said.

To bridge the gap, he suggested removal of tariff and non-tariff barriers, tackling logistical hurdles, and boosting connectivity through corridors such as the International North-South Transport Corridor (INSTC), the Northern Sea Route, and the Chennai–Vladivostok maritime link.

## Online Gaming Bill 2025: Major Platforms Suspend Real-Money Games After Parliament Ban

■ The move comes after Parliament passed the Promotion and Regulation of Online Gaming Bill, 2025, to ban online money games while promoting eSports and online social gaming.

New Delhi: India's realmoney gaming industry has been hit hard after Parliament passed the Promotion and Regulation of Online Gaming Bill, 2025, which bans all money-based online games and prescribes penalties of up to ₹1 crore and jail terms for violations. Soon after the



legislation was cleared, leading platforms including Mobile Premier League (MPL), Zupee, Dream Sports, Gameskraft, and Probo announced the suspension of their realmoney offerings.

MPL, one of India's largest gaming companies with over 120 million users, said it would immediately halt money-based games. "Effective immediately, we are suspending all gaming offerings involving money on the MPL platform in India. New deposits will no

longer be accepted, but customers can withdraw their balances seamlessly," the company said in a LinkedIn post. Rival Zupee also confirmed it would discontinue paid games while continuing to offer free titles such as Ludo Supreme, Snakes & Ladders, and Trump Card Mania.

### PM Modi: Recalls 'Operation Sindoor' Resolve, Launches Key Development Projects

### **11 ISL Clubs Urge Supreme Court Lawyers to Highlight Existential Crisis** ■ The letter from the ISL clubs came a day

before a SC hearing of the case on Friday.

New Delhi: In a rare collective move, 11 Indian Super League (ISL) clubs have written to the senior lawyers assisting the Supreme Court of India, urging them to draw attention to the "existential crisis" facing Indian football's top-tier league. The appeal comes a day before the apex court's scheduled hearing of the case on Friday.

The clubs expressed deep concern over the uncertainty surrounding the future of the ISL, requesting an urgent judgment to avoid a

complete standstill in Indian football. The letter, addressed to amici curiae Gopal Sankaranarayanan and Samar Bansal, called for immediate clarity to safeguard the livelihoods of thousands engaged in the sport. "Given that football clubs, their players, employees, and stakeholders are the most directly affected by the current standstill, we humbly request that our concerns be placed before the Hon'ble Bench," the clubs wrote.

The signatories include Bengaluru FC, Hyderabad FC, Odisha FC, Chennaiyin FC, Jamshedpur FC, FC Goa, Kerala Blasters FC, Punjab FC, NorthEast United FC, Mumbai City FC, and Mohammedan Sporting. The crisis erupted after Football Sports Development Limited (FSDL), the ISL organisers and commercial partners of the All India Football Federation (AIFF), announced on July 11 that the 2025-26 season was on hold. The uncertainty stems from the impending expiry of the



Master Rights Agreement (MRA) between FSDL and AIFF, signed in 2010 and due to end on December 8, 2025. The AIFF currently receives ₹50 crore annually under the agreement, but negotiations on its renewal remain stalled. The clubs said a verbal stay on discussions regarding the MRA since April 30, 2025, has frozen planning for the upcoming season.

Several clubs have already paused operations or suspended player salaries, with revenues hit hard due to lack of clarity.


