PANAJI: Goa has completed the enumeration process for the Special Intensive Revision (SIR) of Electoral Rolls 2026, with 91.55% of Enumeration Forms collected and digitised, election authorities said on Saturday. The revision is being carried out with January 1, 2026, as the qualifying date, following a revised schedule issued by the **Election Commission of** 

India (ECI) on November 30.Out of a total 11,85,034 electors as on October 27, 2025, 10,84,956 **Enumeration Forms** (EFs) were collected, while 1,00,078 electors (8.45%) were marked as ASDD/uncollectable cases after due field verification by Booth Level Officers (BLOs), including a minimum of three site visits. # When Loose Talk Becomes a Liability

h Political parties survive not just on ideology or numbers but on coherence. In that sense, the warning issued by Goa BJP president Damodar "Damu" Naik to party leaders to avoid harming the party's image is less about authoritarian control and more about an organisation struggling to contain the damage caused by its own undisciplined voices. The real issue here is not the party. It is the conduct of certain leaders who appear to confuse public posturing with responsible politics.

In any ruling party, especially one governing a sensitive and economically fragile state like Goa, public statements carry weight. Words spoken casually by senior leaders do not remain personal opinions. They become political signals, administrative distractions and, at times, convenient ammunition for opponents. When such remarks hint at corruption, illegality or administrative failure without evidence or follow-through, they create uncertainty without accountability.

That is not courage. It is carelessness.The recent spate of comments by some BJP leaders, linking governance failures to alleged corruption in Goa's tourism belt, must be viewed through this lens. Goa has just witnessed a tragic nightclub fire that exposed serious lapses in enforcement and safety norms. This was a moment that demanded sobriety, coordination and responsible leadership. Instead, what followed were loosely framed allegations aired in public, giving the impression of a government at war with itself. There is a difference between raising concerns through institutional channels and performing outrage in front of microphones.

Leaders who truly want reform push for action, inquiries and corrective measures. Leaders who speak first and think later often leave behind confusion rather than solutions. By choosing the

What is worrying is the growing tendency among certain politicians to use public criticism as a shield. Once a statement is made, any attempt at clarification or accountability is portrayed as victimisation.

This culture of political freelancing may serve individual egos, but it does little for governance. In fact, it erodes public trust. Citizens are left wondering whether leaders are serious about reform or merely distancing themselves from potential fallout.Goa's political environment is already volatile. Tourism, the backbone of the state's economy, is under constant scrutiny for regulatory lapses and safety concerns. In such a climate, irresponsible statements from within the ruling establishment can cause real harm. Investors hesitate. Tourists worry. Officials become riskaverse. None of this helps the state.

The BJP, as an organisation, has built its strength on structure and hierarchy. That structure exists precisely to prevent chaos and contradiction. Leaders who ignore this framework undermine not just the party but the stability of governance itself. Internal mechanisms exist for a reason. Using them is not weakness. It is maturity. There is also a moral obligation that comes with power.

Leaders cannot claim insider knowledge of wrongdoing and then stop at soundbites. If there is evidence of corruption or illegality, it must be pursued relentlessly through lawful means. Anything less reduces serious issues to political theatre. Naik's warning should ideally serve as a course correction. It is a call for restraint, not silence. Debate is healthy, but it must be purposeful. Criticism is valid, but it must be responsible.

The public does not benefit from leaders who speak without strategy or accountability. Goa needs governance that is steady, credible and focused. That requires leaders who understand that discipline is not the enemy of transparency. Uncontrolled speech, especially from those in power, is not bravery. It is a liability the state can ill afford.

#### Goa Deserves Straight Answers, Not Rhetoric

elcome back to Goa, Arvind Keiriwal, the self-styled master of clean politics and governance by algorithms. As you arrive ahead of the Zilla Panchayat elections, Goans have some pointed questions that deserve clear answers, not slogans or selective silence. First, there are allegations raised by Paul Lobo of Cavelossim, a founder member of the Aam Aadmi Party in Goa. These are not charges coming from political rivals but from within the party's own early ranks. Goans would like to know why these concerns have not been addressed transparently and why internal dissent in AAP often ends in silence or sidelining. Second, the Swati Maliwal episode and the socalled Sheesh Mahal bungalow controversy in Delhi cannot be brushed aside as media invention. A party that claims moral superiority must be willing to explain how power is exercised behind closed doors and how public money is justified in the name of governance.

Third, serious questions remain about the alleged ₹45 crore liquor scam and claims that funds were routed through hawala to finance election campaigns, including in Goa. If AAP prides itself on honesty, it must clearly state where this money went and how it was used. Claims of noble intentions are not substitutes for accountability. Finally, Goans have not forgotten the India Against Corruption movement. What became of Anna Hazare? Was that movement genuinely organic, or was it politically choreographed with backing from established power centres? This is not about party loyalty. It is about truth. Goans have been misled often enough. If AAP seeks trust, it must earn it with honest answers. Enough is enough.


#### Resignation That Speaks Louder Than Rhetoric

amrao Wagh's decision to resign as vice president of the Aam Aadmi Party in Goa ahead of Arvind Kejriwal's visit deserves to be seen for what it is. A moment of political clarity. It takes courage to step away after realising that the promises made to Goa do not match the intentions being pursued. The truth is often bitter, but it cannot be ignored forever. Across India, there is growing recognition that AAP was built on a carefully crafted narrative during the India Against Corruption movement. The involvement of Anna Hazare, Arvind Kejriwal, Kiran Bedi and others gave the movement moral weight, but what followed was a political transformation that many original supporters did not sign up for. That is precisely why principled leaders like Prashant Bhushan and others chose to leave AAP rather than compromise their values.

Events in recent years have only deepened these doubts. The Sheesh Mahal controversy and the disturbing allegations surrounding the treatment of Rajya Sabha MP Swati Maliwal raise serious questions about internal culture and accountability within the party. These are not minor issues that can be dismissed as political propaganda. They strike at the very foundation of the values AAP claims to represent. Closer home, when a founder member of AAP Goa, Paul Lobo, raises allegations against his own party, it is convenient to label them as lies. But why would insiders repeatedly speak out if everything was as clean and transparent as claimed? The electoral losses suffered by Arvind Kejriwal and Manish Sisodia in Delhi also suggest that voters are beginning to see through the narrative.Ramrao Wagh's exit should serve as a warning. Goa must think carefully before embracing a party whose actions increasingly contradict its words. Say no to misleading politics dressed up as reform.

# Cyber Crime Police Crack 2 Major Fraud Cases in Goa

■ Fake Investment Scam and Illegal Call Centre Busted.

**PANAJI:**The Cyber Crime Police Station, Goa, has detected two major cyber fraud cases, leading to multiple arrests in connection with a fake investment scam involving ₹69.75 lakh and the operation of an illegal international call centre in Old Goa.In the first case, registered as Crime No. 24/2025 on August 13, 2025, the Cyber Crime Police arrested a 62-year-old man from Kerala for his involvement in a fake investment scam that duped a resident of Porvorim of ₹69.75 lakh. The accused allegedly impersonated a reputed investment firm using a WhatsApp number and



a fake trading application named "360-ONE-HNW," luring the victim with promises of high returns. The complainant was falsely informed that his investment had grown to ₹5 crore and was asked to pay a service fee to release the profits, resulting in substantial financial loss. Following a detailed technical and financial investigation,

police arrested Prasantha Bose A, a resident of Kalamassery, Ernakulam. Investigations revealed that ₹46 lakh was credited to his bank account at the first layer, which was later routed to multiple associate accounts. Police further found that the same account was linked to 23 other cyber fraud cases across several states, involving a total fraud amount of ₹2.10 crore. The accused has been produced before the court and remanded to police custody.In the second case, the Cyber Crime Police conducted a late-night raid at Bainginium, Old Goa, on December 12, 2025, and busted an illegal call centre targeting citizens of the United States.

# Surch By Romeo Lane

#### Birch by Romeo Lane Fire Probe Widens

Panchayat Role, Financial Links Under Scanner

**PANAJI:** The investigation into the deadly Birch by Romeo Lane fire incident has entered a crucial phase, with Goa Police expanding the scope of the probe to examine administrative lapses, financial trails and the role of local authorities, even as efforts continue to bring key accused to India. Police sources said the deportation process of the Luthra brothers is actively underway, with Goa Police working closely with central agencies to expedite their return. Investigators believe their questioning is vital to establish the sequence of decisions taken before the fire and to identify possible violations of safety norms. In a significant development, the Sessions Court at Mapusa has issued notices on anticipatory bail applications filed by Arpora Panchayat Sarpanch Roshan Redkar

and Secretary Raghuvir Bagkar. Police have sought time to submit a detailed reply, signalling that the probe is now closely scrutinising the panchayat's role in clearances, oversight and compliance. The matter will be heard on December 16 at 2.30 pm. Meanwhile, custodial interrogation of accused Bharat Kohli has been extended by six days, indicating that investigators are following multiple leads. Police sources said the extension was sought to confront the accused with documentary evidence and statements already recorded. More than 50 statements of officials, workers and victims have been recorded so far, reflecting the scale of the inquiry. Authorities said the investigation is focusing not only on the immediate cause of the fire but also on systemic failures that may have contributed to the tragedy.

# CM Sawant Says Invisible Opposition Reflects BJP's Ground Strength in Rivona

Highlighting his government's welfare initiatives, the Chief Minister said that soon after he assumed office, several Goans approached him after receiving court notices for demolition of their houses declared illegal.

### Mandrem Resort Event Exposes "Corruption Cartel" in Goa: AAP

AAP Goa president Amit Palekar alleges illegal permissions, fire safety lapses under BJP rule.

PANAJI: Aam Aadmi Party (AAP) Goa president Amit Palekar on Saturday launched a scathing attack on the BJP-led Goa government, alleging the existence of a "corruption cartel" and accusing the administration of allowing illegal activities that endanger public safety. Palekar claimed that a resort in Mandrem is hosting an event in an illegal structure without mandatory permissions, including a Fire No Objection Certificate



(NOC), putting the lives of unsuspecting people at risk. He alleged that the resort had earlier defied the Tourism Department and was even fined, yet continues to operate with impunity. "Despite repeated violations, this is being allowed right under the nose of authorities, who

appear helpless due to powerful influence," Palekar alleged, adding that the BJP government had failed to learn any lessons and had completely lost control over the administration. Taking a swipe at Chief Minister Pramod Sawant, the AAP leader said the situation reflected a breakdown of governance. He remarked that the popular slogan "Go Goa Gone" had become a reality under the present government, asserting that nothing would change except "money changing hands".

# Cortalim MLA demands immediate crackdown on illegal scrapyards after major Verna fire

VERNA: A huge fire at a scrapyard in Verna on Friday afternoon prompted Cortalim MLA Anton Vas to demand an immediate, state-wide crackdown on illegal scrapyards, warning that such unauthorised units pose "grave risks" to surrounding institutions and nearby residents. Vas, who rushed to the site at Quelossim after receiving a phone call, said he found no clarity on how the scrapyard was functioning or how the fire started. "I reached here from Vasco the moment I got the call. I tried to



understand how the scrapyard caught fire, but there's no clarity on the existence of this scrapyard in the first place," he said. "The owners themselves claim they were not present when the incident occurred. This is a very large scrapyard and the fire was massive."He said preliminary information indicated that the scrapyard was functioning

without approvals. "I am told the scrapyard was operating without permissions and that the Quelossim panchayat had already sought its demolition. But the PWD and electricity department did not turn up on the day of demolition, leaving the action pending," Vas said, questioning how such a large facility could continue operations "without anyone's knowledge."Vas also highlighted the unusual activities being carried out within the scrapyard. "Apart from scrap, people here were rearing hens and even goats.

Police stated that despite receiving the amount, the accused neither arranged the admission nor returned the money, thereby dishonestly cheating the complainant of ₹12.86 lakh.Further investigation is in progress and is being carried out by PSI Plato Carvalho of Vasco Police Station.

#### **Mapusa Scooter Rider Dies After Crashing Into Car Door at Dattawadi**

MAPUSA: A 28-year-old scooter rider lost his life in a tragic road accident at Dattawadi, Mapusa, in the early hours of Friday after allegedly crashing into the open door of a parked car. The incident occurred around 5.30 am when the accused, identified as Suharsh Shekhar Bhartu (38), a resident of Dattawadi, Mapusa, reportedly parked his Punto car (GA-03-Y-1366) on the side of the one-way road leading from Dattawadi to the Maruti Temple without taking proper care and caution. Government Pushes Made in India Manufacturing as Global Supply Bottlenecks Hit Airlines

New Delhi: The government is working on an ambitious plan to develop aircraft that are fully built in India, Civil Aviation Minister Ram Mohan Naidu told Parliament, underlining a shift toward long term self reliance in the aviation sector. ## **IndiGo Says Customer Compensation to Cross Rs 500 Crore After Flight Disruptions**

Airline Begins Review of Cancelled Flights and Stranded Passengers From Early December.

New Delhi:IndiGo has announced that it expects to pay more than Rs 500 crore in compensation to passengers affected by large-scale flight cancellations and severe disruptions earlier this month. The airline said the payments will cover customers whose flights were cancelled within 24 hours of departure and those who were left stranded at select airports across the country. The airline stated that it is currently identifying flights

where passengers faced serious inconvenience on December 3, 4 and 5. Once this review is completed, IndiGo plans to directly contact impacted customers in January to facilitate the compensation process. The carrier emphasised that its aim is to make refunds and compensation transparent, simple and hassle-free. IndiGo said its immediate priority is to complete all pending refunds for affected passengers. According to the airline, a majority of refunds have already been processed,

and the remaining transactions are expected to be credited shortly. The company added that refunds and compensation are being handled with urgency to minimise further inconvenience to customers.

#### **India Expedites Business Visas for Chinese Professionals Amid Improving Ties**

# Delhi Air Quality Reaches 'Severe'; GRAP-3 Anti-Pollution Measures Activated

Worsening Winter Smog Triggers Health and Mobility Concerns in Delhi.

New Delhi: Delhi's air quality deteriorated sharply on Saturday, prompting authorities to invoke GRAP-3 antipollution measures. Early morning readings recorded an overall Air Quality Index (AQI) of 390, classified as 'very poor,' while several localities, including Wazirpur (AQI 443) and Jahangirpuri (AQI 439), entered the 'severe' category. Under GRAP-3, non-essential construction, demolition, stone crushing, and mining activities are suspended. Older diesel goods vehicles are barred from entering the city, schools up to Class 5 shift



to hybrid learning, and offices in Delhi-NCR are allowed to operate with only 50% staff. Environmental experts attribute the worsening air to stagnant winds, vehicular emissions, industrial activity, and crop residue burning

in neighbouring states. Health specialists warned that prolonged exposure to such pollution could trigger asthma attacks, reduce lung function, stress the cardiovascular system, and cause eye and throat irritation. Delhi Airport issued an


advisory, noting that all flight operations are normal, but low-visibility procedures remain in effect. Friday had also seen heavy smog across the city, with the AQI at 386, particularly affecting areas like Ghazipur and Anand Vihar.

■ Chief of Defence Staff Urges Readiness and Discipline as New Officers Join During Operation Sindoor.

New Delhi: Chief of Defence Staff General Anil Chauhan delivered a firm message on the nature of modern warfare while addressing newly commissioned officers at the Air Force Academy in Dundigal. Speaking at the Combined Graduation Parade of the Autumn Term in December 2025, he said conflicts are not decided by slogans or symbolic gestures but by clear intent, disciplined planning and purposeful action, a remark widely seen as a pointed message to Pakistan. General Chauhan stressed that empty rhetoric has little value on the battlefield. He said genuine military strength flows from professionalism, institutional discipline



and the ability to execute decisions decisively. Referring to recent regional developments, he noted that several parts of the world continue to suffer from instability driven by weak institutions and reactive decision making. Such fragility, he observed, often results in prolonged insecurity and conflict.Contrasting this environment, the Chief of Defence Staff highlighted India's institutional resilience.

#### Mamata Banerjee's Seat Sees 4 Times More Voter Deletions Than Suvendu Adhikari's Nandigram

Mamata Banerjee's Constituency Records Nearly Four Times More Deletions Than Nandigram.

New Delhi: Fresh data from the Election Commission has revealed sharp contrasts in voter deletions across West Bengal, with Chief Minister Mamata Banerjee's Bhabanipur constituency emerging as one of the most affected seats. Bhabanipur recorded almost four times more deletions than Nandigram, the constituency of Leader of Opposition Suvendu Adhikari, adding political intensity ahead of the release of draft electoral rolls. According to constituencywise figures released after the conclusion of the Special Intensive Revision process, Bhabanipur saw 44,787 names removed from its voter list of 2,06,295 as of January 2025. In comparison, Nandigram registered 10,599 deletions out of 2,78,212 voters. The deletions



standard grounds including deaths, relocation, untraceable addresses and duplicate entries, with election authorities maintaining that uniform criteria were followed across the state. Despite the attention on Bhabanipur, it did not top the list statewide. The highest number of deletions was reported in Chowringhee in north Kolkata, where 74,553 voters were struck off. Other constituencies with large-scale deletions included Kolkata Port with 63,730 removals,



Behala East with 53,036 and Behala West with 52,247. Several of these seats are held by senior Trinamool Congress leaders who have historically won by comfortable margins. BJP-held constituencies also saw notable deletions, though generally fewer than the highest figures in Kolkata. Asansol South recorded 39,202 deletions, while Siliguri saw 31,181 names removed. Both seats carry political significance due to their electoral margins and regional importance.

## "India an Important Partner": US Lawmakers Move to End Trump Tariffs

House Resolution Targets Emergency Powers Used to Impose Duties of Up to 50 Percent on Indian Imports.

New Delhi: A group of United States lawmakers has introduced a resolution in the House of Representatives seeking to roll back tariffs imposed on Indian imports under President Donald Trump's national emergency declaration. The move reflects growing concern in Congress that the duties are unlawful, economically damaging and harmful to the long term partnership between the United States and India.The resolution aims to terminate the emergency declaration that enabled the imposition of steep tariffs under the International **Emergency Economic** Powers Act.

If adopted, it would rescind the additional duties placed on Indian goods in August 2025, including a secondary surcharge that pushed



total tariffs on several products to as high as 50 percent.

Lawmakers backing the measure argue that the tariffs have disrupted supply chains, raised costs for American consumers and placed unnecessary pressure on domestic industries. They have also warned that the duties undermine one of Washington's most important strategic and economic relationships at a time when cooperation with India is seen as critical in the Indo Pacific region.Supporters of

the resolution have highlighted the deep trade and investment ties between the two countries.

Several US states maintain strong economic links with India through manufacturing exports, technology partnerships and investments by Indian companies that support thousands of American jobs. According to the lawmakers, the tariffs effectively act as a tax on American households and businesses already grappling with higher prices.

Former Stars Question Roles as Team Struggles in South Africa Series.

New Delhi: Former Indian cricketers have expressed concern over the current T20I batting setup, focusing on vice-captain Shubman Gill and captain Suryakumar Yadav, with Gautam Gambhir weighing in on strategic concerns.Mohammad Kaif suggested that Shubman Gill may need a break from the ongoing five-match series against South Africa.

Speaking on his YouTube channel, Kaif noted that Gill has struggled with consistency in the middle-order, often



attempting aggressive strokes but getting caught or mistiming deliveries. "Even vice-captains have been dropped before. If it is in the team's interest to rest Gill and try other options, there is nothing wrong with it," Kaif said.

He also criticized what he sees as unequal opportunities for players, pointing out that others. like Sanju Samson, have not been given enough chances despite strong performances. India's T20I captain, Suryakumar Yadav, is under scrutiny for a prolonged slump in form. Former India batter Aakash Chopra highlighted that Yadav has scored only 227 runs in 20 innings since November last year, averaging 13.35, with minimal impact at the top of the order. "You are the captain and a top-order batter. Scoring runs consistently is vital, especially with the T20 World Cup approaching," Chopra said, stressing the need for Yadav to regain form ahead of the 2026 tournament in India and Sri Lanka.

The event marked the opening of his GOAT Tour of India and was held amid high anticipation at the Yuva Bharati Krirangan and at Lake Town, where the statue has been installed by the Sree Bhumi Sporting Club. The statue depicts Messi holding the FIFA World Cup trophy, symbolising his historic triumph at the 2022 World



Cup. Crafted from iron and completed in a record 40 days, the installation has drawn widespread attention and is being described as the tallest statue of the footballer anywhere in the world. Messi virtually unveiled the

structure after giving prior consent, with organisers saying he and his team expressed satisfaction after viewing it. Messi arrived in the city early in the morning, triggering scenes of excitement across Kolkata.
