



Nearly 9 Crimes a Day in Goa in 2025

Over 3,200 offences registered in a year; rape and kidnapping cases remain in triple digits

PANAJI: The Goa government has reported that a total of 3,243 criminal cases were registered across the State in 2025, according to the official data tabled in the Goa Legislative Assembly.

The information was provided by Chief Minister and Home Minister Dr Pramod Sawant in



a written reply to an Unstarred Legislative Assembly Question (LAQ No. 107) moved by MLA Vijai Sardesai .

As per the crime statistics for the last five years (2021–2025),

NO DETENTION POLICY

No-Detention Policy to Stay for Classes V, VIII in Goa Next Academic Year

PANAJI: The Goa government has opted to retain the no-detention policy for students of Classes V and VIII for the academic year 2026–27, ensuring that no child will be held back on account of academic underperformance.

The decision has been taken as an interim measure, with the State awaiting detailed implementation guidelines

from the Union Ministry of Education following recent amendments to the Right to Education (RTE) framework.

State officials clarified that while the Centre amended the Right of Children to Free and Compulsory Education Rules in December 2024, the no-detention policy has not been formally withdrawn. In the absence of clear directions from the Union government,

Entertainment Circuit Link Emerges In Double Murder Of Russian Nationals In Goa

MANDREM: Investigators in Goa are widening the scope of their inquiry into the killing of two Russian nationals, examining possible connections within the State's event and entertainment ecosystem as they piece together the sequence of events that led to the murders.

Police officials said the accused, Alexei Leonov, and the two victims — Elena Kashanova and Elena Vaneeva — appear to have intersected professionally through performance-based engagements linked to weddings and private events. Law enforcement agencies are now tracking

contacts with event planners, venue managers and individuals who may have hired them for performances.

Senior officers said the investigation is focused on reconstructing travel patterns, social interactions and professional associations to identify inconsistencies and potential triggers behind the crime. Police are also examining whether the trio was engaged independently or through intermediaries.

Leonov, who has been residing in India for the past two years, has allegedly admitted to killing both women. However, officials stressed that his

“I Am a Karyakarta, Nitin Nabin Is My Boss”: PM Modi Welcomes BJP's Youngest National President

■ Forty five year old leader takes charge, signalling generational shift and organisational focus ahead of key elections

New Delhi: Prime Minister Narendra Modi on Tuesday congratulated Nitin Nabin on assuming charge as the National President of the Bharatiya Janata Party, calling himself a party worker and describing the new chief as his boss. The remark underlined the BJP's emphasis on organisational discipline

and collective leadership as Nabin formally took over the party's top post.

At 45, Nitin Nabin has become the youngest leader to head the BJP and the 12th person to hold the position. He succeeds Jagat Prakash Nadda at a time when the party is preparing for several crucial state elections this

year and next, as well as laying the groundwork for the 2029 Lok Sabha polls. His elevation is widely seen as a signal of generational transition and renewed focus on strengthening the party organisation from the grassroots upward.

Nabin's appointment was uncontested and backed by the party's



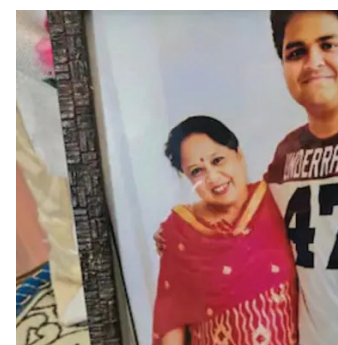
senior leadership. He brings nearly two decades of political and organisational experience, having risen through the ranks of the BJP's youth wing in Bihar.

Roads, Water Kill. No Accountability: Rahul Gandhi Flags Urban Failures After Noida Tragedy

■ Tech professional's death sparks debate on governance lapses, safety gaps, and delayed rescue response

New Delhi: The death of a young software professional in Noida has triggered a sharp political response and renewed scrutiny of urban infrastructure and administrative accountability. Congress MP Rahul Gandhi described the incident as a stark example of what he termed India's “urban collapse”, arguing that such tragedies stem not from lack of resources or technology but from a failure of responsibility.

The remarks followed the death of 27 year old Yuvraj Mehta, who worked in Gurugram and lived in Noida. On Friday night, while returning home amid dense fog, Mehta lost control of his vehicle near Sector 150. Poor visibility and a sharp right turn led his car into an unmarked roadside ditch nearly 20 feet deep and filled with water. The stretch reportedly had no barricades, warning signs, or lighting to alert motorists to the hazard. Trapped



inside the submerged vehicle, Mehta struggled for a prolonged period while awaiting help. Unable to swim, he reportedly remained in the water for close to 90 minutes and even managed to call his father in panic, informing him that his car had fallen into a drain. Despite the



proximity of the incident to residential areas and major roads, rescue efforts were delayed. The incident has raised serious concerns about emergency preparedness and the condition of urban infrastructure in rapidly developing regions close to the national capital.

Uniformity or Freedom: What should Universities Really Stand For?

Vijai Sardesai's opposition to uniforms in colleges has reignited a debate that goes far beyond dress codes. When the Goa Forward Party chief said universities are not schools and young minds should not be controlled, he was making a political statement, but also a philosophical one. At its core, his argument challenges how India understands higher education and the role of students within it.

Sardesai's resistance to college uniforms stems from his belief that universities must function as spaces of autonomy. In his view, students at the higher education level are adults, capable of making choices and bearing responsibility for them. Enforcing uniforms, he argues, reflects a lack of trust in young people and an urge to regulate rather than engage. For him, individuality is not a threat to education but a prerequisite for independent thinking.

This perspective resonates with the traditional idea of a university as a place where identities are shaped and ideas contested. Unlike schools, colleges are meant to expose students to the diversity of thought, background, and experience. Clothing, while not the most important form of expression, is often the most visible. Restricting it can signal an institutional discomfort with difference. Sardesai's emphasis on students as "stakeholders" reflects a growing demand that universities treat learners as partners in the academic process, not passive recipients of rules.

There is also a practical argument embedded in his stance. Higher education is supposed to prepare students for life beyond campus, where decision-making, self-regulation, and negotiation of social norms are essential skills. Shielding students from freedom until graduation can be counterproductive. Critics of uniforms argue that learning to manage choice is itself part of education, and that universities should guide this process rather than suppress it.

mere authoritarianism. Many educators and administrators defend uniforms on the grounds of equality. In campuses marked by sharp economic differences, clothing can quickly become a symbol of privilege. Students from poorer backgrounds may feel pressured to match fashion trends they cannot afford. Uniforms, supporters say, reduce visible class divisions and create a sense of belonging that transcends income and background.

There are also concerns about decorum and academic focus. Some believe that a uniform or strict dress code reinforces the seriousness of the

learning environment and minimises distractions. In professional courses, uniforms are often justified as early exposure to workplace expectations, where dress codes are common and sometimes mandatory. From an administrative perspective, uniforms also make identification and campus security easier.

Sardesai's opposition implicitly challenges these arguments by questioning whether enforced sameness is the right way to achieve equality and discipline. His position suggests that universities should address inequality through financial aid, counselling, and inclusive policies, not by regulating appearance. While this is an appealing ideal, it assumes institutions have the resources and intent to tackle deeper structural issues, which is not always true.

The debate also raises a crucial question about governance. Who should decide what students wear? When rules are imposed from above without consultation, resentment is almost inevitable. Universities that claim to promote democratic values must reflect them in everyday decision-making. If dress codes are necessary, students should have a meaningful role in shaping them. Sardesai's remarks strike a chord because they echo a wider frustration with paternalistic policies that ignore student voices.

A middle path may be more realistic than absolute positions. Instead of mandatory uniforms, universities could adopt flexible dress guidelines that ensure dignity and inclusivity without erasing individuality. Such policies, if developed through dialogue, could balance freedom with sensitivity to social realities.

Ultimately, Sardesai's opposition to uniforms is less about clothing and more about control. It forces institutions to confront an uncomfortable question. Do they see students as adults capable of judgment, or as children who must be managed? The answer will shape not just what students wear, but what kind of citizens universities hope to produce.

Traffic chaos at Porvorim during flyover construction

The ongoing flyover construction at Porvorim has turned daily commuting into a test of patience and endurance for thousands of residents. While infrastructure development is necessary, the manner in which traffic is currently being handled reflects poor planning and little regard for the public.

During peak hours, traffic comes to a near standstill on the NH66 stretch and adjoining internal roads. What should be a 10-minute drive often takes over 45 minutes. Office-goers, students, ambulance drivers, and public transport users are all bearing the brunt of the chaos. The lack of clear signage, frequent changes in diversions, and inadequate presence of traffic personnel have only worsened the situation.

What is particularly concerning is the absence of effective traffic management during critical hours. Road narrowing, heavy machinery movement, and unregulated parking around the construction zone create daily bottlenecks. Residents are rarely informed in advance about changes in traffic flow, leaving commuters confused and frustrated.

Development cannot come at the cost of public convenience and safety. Authorities must ensure proper planning, deploy sufficient traffic police, install clear directional boards, and consider night-time construction to minimise disruption. Temporary service roads and strict enforcement against illegal parking are also urgently needed.

Porvorim is a vital junction connecting several parts of Goa. If corrective steps are not taken immediately, the situation is bound to deteriorate further. Citizens deserve better coordination and accountability during such major infrastructure projects.

Assault And Mob Violence Cases Decline In Goa

■ No Gang War Reported In Last Three Years: CM

PANAJI: The Goa government has informed the Legislative Assembly that there has been no increase in cases of assault and mob violence in the State over the last three years, and that no incidents of gang war have been reported during this period.

According to the data, 321 cases of assault were reported in 2023, which declined to 315 in 2024 and further dropped to 252 in 2025. Incidents of mob violence also showed a downward trend, with eight cases reported in 2023, seven in 2024 and six in 2025. No cases of



gang war were reported during the last three years.

The government stated that no cases of dacoity were reported in 2023. In 2024, three cases were registered, all of which were detected and chargesheeted. In 2025, five dacoity cases were reported and detected, of which one has been chargesheeted while investigations are ongoing

in the remaining four cases.

Chief Minister Pramod Sawant said the data indicates effective policing and preventive measures across the State.

"There has been no increase in incidents of assaults and mob violence in 2025 as compared to 2023 and 2024. The concerned areas are closely monitored and strategic plans are introduced to prevent such crimes," Sawant stated in his reply.

The government clarified that taluka-wise records are not maintained, but police station-wise data has been compiled and

detailed in Annexure-A of the reply. Information regarding weapons recovered, damage to public or private property and compensation provided under victim compensation schemes has also been furnished in the annexure.

Replying to a query on a high-level law-and-order review meeting chaired by the Chief Minister following the Baina and St Cruz robberies, the government said the minutes of the meeting could not be furnished under Rule 37(15) of the Procedure and Conduct of Business of the Goa Legislative Assembly, 1992.



After Meeting Defence Minister, Goa CM Says No Move to Hand Over Dabolim Airport to Navy

PANAJI: Chief Minister Pramod Sawant on Monday said that Defence Minister Rajnath Singh has categorically assured the Goa delegation that there is no proposal to hand over the entire Dabolim International Airport to the Indian Navy and that civil aviation operations will continue in the interest of the state.

Speaking after meeting the Defence Minister in New Delhi, Sawant said the assurance clearly dispels speculation about the possible closure of the airport for civilian use. In a statement issued late Monday evening, he accused the Opposition of creating unnecessary confusion among the public over the issue.

"After our meeting with the Defence Minister, it is absolutely clear that civil operations at Dabolim airport will continue. There

is no plan to transfer the airport to the Navy," Sawant said.

The Chief Minister said he, along with Minister for Industries and Panchayats Mauvin Godinho, highlighted the importance of retaining civilian flights at Dabolim for the growth of tourism and the overall development of Goa. He added that Rajnath Singh gave a firm assurance that Goa's interests would be protected.

The delegation that met the Defence Minister included Rajya Sabha MP Sadanand Shet Tanavade, Industries and Panchayat Minister Mauvin Godinho, and BJP MLA Nilesh Cabral.

Sawant reiterated that there is no proposal under consideration to discontinue civil operations at Dabolim International Airport and that the airport will continue to cater to civilian passengers.

No Evidence Of Illegal Religious Conversion Network In Goa: CM

PANAJI: The Goa government has said it is aware of the arrest of Ayesha alias S.B. Krishna alias Nikki by the Uttar Pradesh Police in connection with an alleged unlawful religious conversion case

registered in Agra.

Ayesha was arrested under FIR No. 228/2025 at Sadar Bazar Police Station, Agra, under Sections 87, 111(3) and 111(4) of the Bharatiya Nyaya Sanhita (BNS) and Section 3(5) of the Uttar Pradesh Prohibition of Unlawful Conversion of



Religion Act, 2021.

The arrest was carried

out on July 17, 2025, with assistance from Old Goa Police, after a team from the Uttar Pradesh Police traced the accused to Flat No. 227, first floor, behind Healthway Hospital at Bainguinim in Old Goa, where she was residing at the time.

Congress Flags 'Grave Irregularities' in Electoral Roll Revision

■ Seeks Halt to Voter Deletions in Goa

PANAJI: The Goa Pradesh Congress Committee (GPCC) has lodged a fresh complaint with the Chief Electoral Officer (CEO) of Goa, alleging large-scale violations and misuse of Form-7 during the ongoing Special Intensive Revision (SIR) of electoral rolls in the state, and warning that the irregularities pose a serious threat to citizens' constitutional right to vote.

In a detailed representation dated January 19, GPCC president Amit Patkar said the complaint was a continuation of an earlier submission made on January 13, but noted that subsequent disclosures had revealed "far more serious and systemic lapses" in the revision



process. The Congress has alleged that Form-7, meant for raising objections to entries in electoral rolls, is being misused to facilitate bulk and mechanical deletion of voters across multiple constituencies.

Patkar stated that official Form-10 data now in the public domain shows that the problem is not limited to a single constituency, but extends across several areas, including Navelim, Tivim and Mapusa.

Agonda Residents Flag Flaws in Draft CZMP-2019, Seek Expert Explanation and Time Extension

CANACONA: Agonda coastal residents have pointed out several discrepancies in the draft Coastal Zone Management Plan (CZMP)-2019 maps and have demanded an extension of the deadline for submitting objections, along with deputation of experts to explain the technical details of the maps. Following an



emergency gram sabha, the village panchayat has decided to write to the concerned authorities seeking both.

The emergency gram sabha was convened by Agonda Sarpanch Nilesh Pagui after a large number of residents

gathered at the panchayat office seeking clarification on the draft CZMP-2019 maps submitted by the government to the village panchayat, inviting public comments and suggestions by January 20, 2026.

Residents informed the gram sabha that while they have several valid objections to raise, they are unable to do so effectively without expert guidance.

Nearly 2,000 Goans Employed At Mopa Airport; Majority Staff From Pernem: Goa CM

PANAJI: Chief Minister Pramod Sawant has said that the Manohar International Airport at Mopa has generated significant employment opportunities for local residents, particularly from North Goa, while reiterating that certain operational

details cannot be placed in the public domain due to confidentiality constraints. Highlighting Goa's status as a globally preferred tourist destination, Sawant said the growth of tourism and allied industries across the State has expanded employment avenues, with both Dabolim and Mopa airports playing a key role in



facilitating tourist movement based on traveller convenience.

Lifesavers Rescue Eight From Drowning, Thwart Theft Attempt at Betalbatim Beach

PANAJI: Drishti Marine lifesavers rescued eight persons from drowning incidents across Goa's coastline over the weekend, while also foiling a theft attempt at Betalbatim beach. In addition, lifesavers administered first aid to two individuals and successfully traced two missing children on different beaches.

At Ashwem beach, a 64-year-old woman tourist from Pune was rescued after experiencing difficulty in the water. Lifesaver Chandrakant Devji responded using a rescue tube, with support from Darpan Revankar on a jet ski, and safely brought the woman to shore.

At Anjuna beach, a 24-year-old male tourist from Mumbai was caught in a rip current about 60 metres offshore. Lifesaver



Vinod Salelkar carried out a swift rescue and brought the tourist safely back to land.

At Baga beach, an 18-year-old male tourist from Delhi was rescued after struggling in the water. Lifesaver Suvrabh Kumar used a rescue board to bring him safely ashore. At the same beach, a four-year-old boy from Pune was reported missing. A coordinated search operation was launched, and the child was traced at another stretch of the beach by lifesaver Biliyam

Surim and reunited with his guardians after verification. At Candolim beach, two male tourists aged 14 and 20 from Hyderabad were caught in a sudden flash rip current while swimming. Lifesavers Sunil Matondkar and Rohit Kandulna responded using rescue tubes and safely rescued both. At the same location, a 17-year-old teenager from Kazakhstan sustained a deep cut on his left foot, and lifesavers on duty administered first aid. At Baina beach, a

five-year-old boy from Uttar Pradesh suffered a jellyfish sting on his leg. Lifesaver Yallappa Chalwadi promptly provided first aid.

At Betalbatim beach, a Russian woman tourist reported her bag stolen while she was in the sea. Lifesaver Ganesh Mesta, who had earlier noticed a suspicious individual, followed and apprehended the suspect. The stolen bag was recovered and returned to the tourist. At Agonda beach, three adults from Saligao—two men aged 35 and 40 and a 37-year-old woman—were caught in a rip current and began drowning. Lifesaver Datta Velip entered the water and secured two victims, while Pralhad Velip rescued another using a jet ski. With assistance from another lifesaver using a surfboard, all three were safely brought ashore.



Agra Youth Held With Drugs Worth Rs 4.31 Lakh at Colomb, Canacona

CANACONA: A 29-year-old man hailing from Agra, Uttar Pradesh, was arrested on Monday evening for allegedly possessing drugs worth Rs 4.31 lakh at Colomb in Canacona.

According to Canacona police inspector Pravin Gawas, the accused, identified as Deepu Singh, who is presently employed at a restaurant in Ourem, Palolem, was caught red-handed with a substance suspected to be charas.

The arrest was made during a search operation conducted near a mosque at Colomb by a police team led by PSI Vishal Velip.

Police have registered the case under Section 20(b)(ii)(B) of the Narcotic Drugs and Psychotropic Substances (NDPS) Act, 1985. The accused has been taken into police custody for further investigation.

Further investigation in the case is being carried out by Canacona PSI Ajit K Velip.

Minor Kidnapped From Ponda, Police Launch Probe

PONDA: Ponda police have registered a case of kidnapping following a complaint lodged by a resident of Ponda, originally from Maharashtra, whose name has been withheld.

As per the complaint, the incident occurred on January 17, 2026, at around 9.30 am, when an unknown accused person/s allegedly kidnapped the minor nephew of the complainant from the



guardianship at Ponda.

Police have registered an offence under relevant sections of law and have initiated an investigation to trace the minor and identify those involved.

Further investigation is being carried out by PSI Sushant Gaonkar of Ponda police station.

Unidentified Woman Found Dead on Railway Track Near Vasco

VASCO: An unidentified woman was found dead on a railway track near the IOC junction, close to MPT 9 Gate in Vasco, on January 18, 2026.

According to police sources, at around 9.47 am, Vasco police received a phone call from the PCR Margao control room stating that a caller had reported a dead body lying on the railway track heading towards the MPT 9 Gate near the IOC junction.

Acting on the



information, police rushed to the spot and found the body of an unknown female, estimated to be between

35 and 40 years of age.

Police observed that the woman's head and one hand were amputated, indicating

that she was run over by a train.

During the scene panchanama, a tattoo was noticed on the right forearm of the deceased bearing the inscription "KARANSINGH KI PATNI PUSHPADEVI," which may help in establishing her identity.

The body has been preserved at the South Goa District Hospital, Margao, for further medico-legal formalities and identification.

Further enquiry in the case is being conducted by PSI Mayur Sawant of Vasco police station.

42-Year-Old Labourer Declared Dead at CHC Kakoda

CURCHOREM: A 42-year-old labourer was declared dead after being brought to the Community Health Centre (CHC) at Kakoda, Curchorem, on January 19, 2026.

As per police sources, at around 11.55 am, the medical officer of CHC Kakoda informed police



that Ranthu Mahto (42), residing near Apollo Pharmacy in Curchorem and originally hailing from Gumla district in Jharkhand, was brought to the health centre by

a 108 ambulance in an unresponsive condition and was declared dead on arrival. Police visited CHC Kakoda and conducted enquiries with Balchandra Naik, who identified the deceased as his labourer. An inquest panchanama was carried out, and the body has been preserved at CHC Kakoda for further medico-legal formalities.

Man Held for Trespass in Restricted Defence Area at INS Hansa

VASCO: A case of criminal trespass has been registered at Vasco police station following a complaint by Lieutenant Commander P. Nithin, Commanding Officer of INS Hansa, Dabolim.

According to the

complaint, the incident occurred on January 18, 2026, at around 10.45 am, at the DVOR area of Varunapuri within the INS Hansa premises. The accused, identified as Mohidin Shaikh, a resident of Katem, Baina, Vasco, allegedly trespassed into the defence land, which



is a restricted area, with the intention to commit an offence.

Police have registered the offence under relevant sections of law. Further investigation in the matter is being carried out by Head Constable 5445 Saish Aijaonkar of Vasco police station.

MMC approves hike in medical allowance, extends benefits to temporary staff

MORMUGAO: The Mormugao Municipal Council (MMC) on Monday held a council meeting during which several key decisions relating to staff welfare and civic facilities were taken.

Briefing the media, MMC Chairperson Girish Borker said the medical allowance for fixed staff, which had been pending since 2022, has finally been revised. The council approved an increase of ₹2,000, taking the allowance from ₹7,000 to ₹9,000. Borker said the decision would provide long-overdue relief to municipal employees.



He added that MMC has been the first municipality in Goa to grant special status to temporary workers. As part of this initiative, it has been decided to provide temporary staff with a medical allowance of ₹3,000. In addition, they will be covered under an insurance scheme of ₹10 lakh. "Temporary workers, especially garbage collectors, are our backbone. We are trying our best to support

them in every possible way," Borker said.

The council also discussed plans to set up a wet waste treatment plant at Sada. Borker said MMC would be the first municipality in the State to have its own wet waste processing facility and that the proposal has been finalised, with work expected to begin soon.

Another important decision taken during the meeting was the appointment of

maintenance contractors for the newly inaugurated Vasco fish market. Borker said the floors at the market can become slippery and require regular cleaning to ensure safety and hygiene. Maintenance contractors will also be appointed for the Sada market complex.

Borker further said councillors have been asked to inform residents about the two wellness centres recently inaugurated at Vasco and Sada by Health Minister Vishwajeet Rane. He said these centres can be used for minor health issues, reducing the rush at the Sub-District Hospital in Chicalim.



Food Safety Drive in Mapusa: Seven Establishments Shut for Unhygienic Conditions

MAPUSA: The Food and Drugs Administration (FDA) conducted a surveillance drive in Mapusa, targeting food business establishments near the Alankar Cinema Theatre area in Bardez, during which several violations related to hygiene and sanitation were detected.

During the drive, a total of 18 food business premises were inspected. Of these, seven establishments—including a cashew shop—were ordered to shut down after they were found operating in unhygienic and unsanitary conditions.

Officials stated that six of the food businesses were directed to stop

operations despite having been earlier trained on hygiene guidelines during previous inspections.

The remaining establishments were issued improvement notices and directed to rectify deficiencies within the stipulated time.

The inspection drive was carried out by Food Safety Officers Amit Mandrekar, Lenin Desai, Sneha Gaude, Sujata Shetgaonkar and Nausin Mulla, under the guidance of FDA Director Shweta Dessai and Designated Officer for North Goa, Richard Noronha.

FDA officials said such surveillance drives will continue across the state to ensure food safety standards are strictly followed and to safeguard public health.

Valpoi Student Selected to Represent Goa at 'Pariksha Pe Charcha 2026'

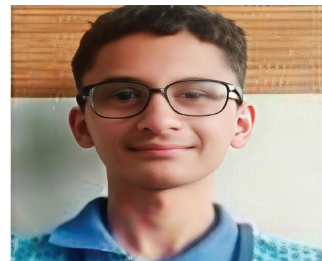

The cyclothon will be virtually flagged off

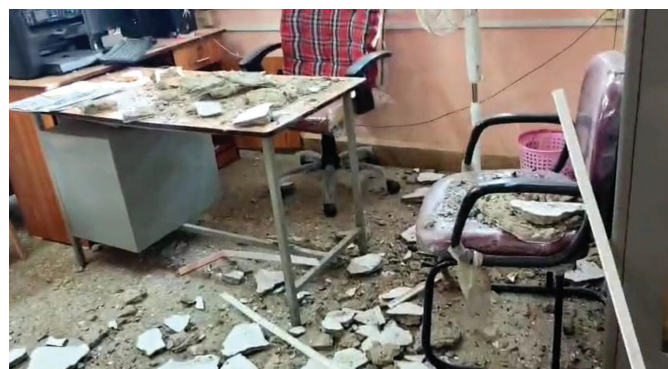

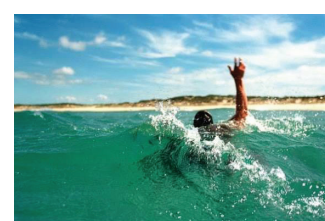
22-Year-Old Nepali Drowns While Swimming at Agonda Beach

Nearly 9 Crimes a Day in Goa in 2025

27 murder cases were reported across the State.

The data shows that kidnapping and abduction cases have steadily increased over the years, rising from 52 cases in 2021 to 103 cases in 2025. Similarly, cases registered under the Information Technology Act rose sharply, with 121 cases reported in 2025, indicating a surge in cyber-related crimes.

Replying to a query on gang-related assaults, the government informed the House that two serious physical assault cases involving groups or gangs were registered between January 2022 and 2025.

These incidents were reported at Fatorda and Panaji police stations and were attributed to group rivalry and personal enmity. Both cases resulted in grievous or bodily injuries and are currently pending trial.

The Home Department also disclosed that one case of assault by police personnel inside a police station was registered during the same period. The incident occurred at Margao Town Police Station in October 2025, involving a PSI, and resulted in a head injury to the victim. The case is presently under investigation.

No-Detention Policy to Stay for Classes V, VIII in Goa Next Academic Year

Goa will continue with the existing no-fail system.

Education Secretary said that the State would maintain the current practice until the Centre issues specific instructions on how the amended rules are to be enforced. He emphasised that the recent changes do not automatically abolish the no-detention provision. "The Centre has modified the 2010 RTE Rules, but it has not done away with the no-detention policy. The implementation guidelines are still awaited," he said.

A notification issued by the Ministry of Education on December 16, 2024, amended the Right of Children to Free and Compulsory Education Rules, 2010, giving States the authority to allow schools to fail students who do not pass year-end examinations. The gazette notification enables State governments to reintroduce regular examinations and detain students who fail to meet promotion standards, while also mandating remedial interventions to help students overcome learning deficiencies.

Vande Bharat Sleeper Train: How India's First Semi-High-Speed Overnight Service Works

New Delhi: India has launched its first Vande Bharat sleeper train, connecting Howrah in West Bengal with Guwahati (Kamakhya) in Assam, as part of Indian Railways' efforts to modernise long-distance travel. The train is designed to make

journeys faster, safer, and more comfortable while supporting regional tourism and religious travel.

The service reduces travel time on the route by about 2.5 hours. It has 16 coaches: eleven 3-tier, four 2-tier, and one first-class AC, accommodating

a total of 823 passengers. Each coach is equipped with modern amenities such as padded berths, individual air ventilation, lighting, power sockets, sliding windows for privacy, and bio-vacuum toilets. Safety features include the Kavach system and emergency talk-back,



ensuring passengers can communicate in case of any issues.

Passengers will also receive premium linen kits

in all AC classes. These kits include a bed sheet, pillow with cover, wool-rich blanket, and hand towel. These measures are intended to enhance comfort and provide a premium experience comparable to modern hotel standards.

The fare structure

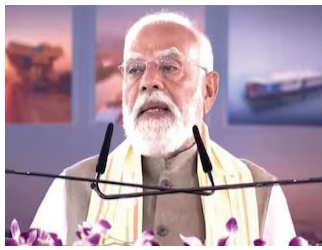
depends on the travel distance and class. AC 3-tier tickets cost Rs 960 for journeys up to 400 km, AC 2-tier fares start at Rs 1,240, and first-class AC tickets are around Rs 1,520. For longer trips nearing 1,000 km, fares range between Rs 2,400 and Rs 3,800.

Infiltration Is a Major Security Threat, Must Be Dealt With Firmly: PM Modi

■ Prime Minister Calls for Identifying and Deporting Illegal Entrants, Warns Against Urban Extremism

New Delhi: Prime Minister Narendra Modi on Tuesday described illegal infiltration as a serious threat to national security and said such elements must be identified and sent back to their country of origin. He asserted that no nation in the world tolerates illegal entrants and stressed that India cannot afford to do so either.

The Prime Minister made these remarks while



addressing a gathering at the ceremony marking Nitin Nabin's assumption of office as the new president of the Bharatiya Janata Party. Emphasising the gravity of the issue, Modi said infiltrators

not only compromise national security but also undermine the rights of the country's poor, youth and marginalised communities.

He noted that even some of the world's most powerful nations are conducting investigations to identify illegal migrants within their borders. India, he said, must take equally firm steps and ensure that those living in the country unlawfully are dealt

with strictly and lawfully. Identifying infiltrators and deporting them, he added, is an urgent necessity.

The Prime Minister also criticised political forces that, according to him, shield illegal entrants for vote bank considerations. Such practices, he said, weaken the nation from within and must be exposed before the public so that citizens understand the long term consequences.



"Committed to Fostering Economic Growth": UAE President Wraps Up New Delhi Visit

■ Key agreements signed as India and UAE deepen strategic, economic, and defence cooperation

New Delhi: UAE President Sheikh Mohamed bin Zayed Al Nahyan concluded a brief but high-impact visit to New Delhi, underscoring the growing momentum in India UAE relations. During the visit, he held wide-ranging discussions with Prime Minister Narendra Modi, focusing on strengthening bilateral cooperation across economic, strategic, and future-oriented sectors.

Both leaders reaffirmed their shared commitment to sustainable development and long-term economic growth, highlighting the deep historical ties and evolving partnership between

the two nations. The discussions reflected a mutual desire to expand collaboration in areas that deliver tangible benefits to people and businesses in both countries.

Prime Minister Modi described the meeting as warm and productive, noting that the talks covered a broad spectrum of issues aimed at reinforcing the multifaceted friendship between India and the UAE. The engagement reaffirmed the comprehensive strategic partnership that has steadily expanded in recent years. Several significant outcomes marked the visit.

India Warns Against Selective Pressure Over Ukraine, Urges Poland to Avoid Pakistan Support

■ Jaishankar Raises Trade Targeting and Terrorism Concerns During High-Level Talks in New Delhi

New Delhi: India has conveyed strong reservations to Poland over what it described as selective and unfair pressure linked to New Delhi's position on the Russia Ukraine conflict, while also cautioning Warsaw against any form of engagement with

Pakistan on issues related to cross border terrorism.

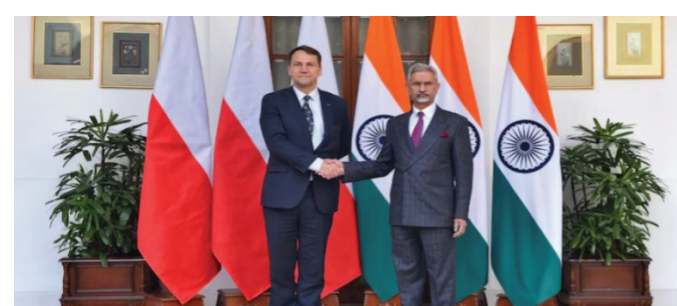
The concerns were raised by External Affairs Minister S Jaishankar during talks with Polish Deputy Prime Minister and Foreign Minister Radoslaw Sikorski in New Delhi. The meeting reviewed the expanding



India Poland Strategic Partnership and included detailed discussions on regional and global

developments amid what both sides described as a period of significant global uncertainty.

Jaishankar underlined that India has been repeatedly singled out through trade related measures and tariffs over its economic engagement with Moscow.



"India Has Shown Willingness to Engage": Poland Eyes Stronger Trade Ties with New Delhi

■ Warsaw looks to deepen economic ties with New Delhi amid tariff pressures and global trade shifts

New Delhi: Poland is actively seeking new trade partnerships in response to rising tariffs in parts of the global market, with India emerging as a key country willing to engage, Polish Deputy Prime Minister and Foreign Minister Radoslaw Sikorski said during his visit to New Delhi.

Highlighting the broader economic context, Sikorski noted that Poland is looking beyond traditional markets as trade barriers increase elsewhere. He stressed the importance

of reinforcing global confidence in free trade and said India's openness to dialogue made it a natural partner in this effort. According to him, strengthening economic ties between India and Poland would also reinforce cooperation between India and the European Union as a whole.

The remarks come at a time when the European Union has faced higher import tariffs from some regions, prompting member states to diversify trade relationships.

'National Anthem Disrespected': Governor Walks Out of Tamil Nadu Assembly

■ RN Ravi Skips Address, Flags Governance, Safety and Democratic Concerns

New Delhi: Tamil Nadu Governor R N Ravi on Tuesday chose not to deliver the customary address to the State Assembly, walking out shortly after proceedings began. The decision followed his assertion that the National Anthem was disrespected when the Tamil anthem was played at the start of the session. A statement issued from Raj Bhavan said the National Anthem had once again been insulted and that a fundamental constitutional duty was disregarded.

According to the Governor's office, the situation inside the House deteriorated when he was allegedly prevented from speaking, with claims that his microphone was repeatedly switched off. Ravi offered a brief greeting in Tamil before leaving the Assembly,

bringing the opening session to an abrupt halt. The episode has further sharpened tensions between the Governor and the DMK government led by Chief Minister M K Stalin, just months ahead of the state Assembly elections.

Under established protocol, the Governor's address traditionally outlines the government's priorities and achievements. However, the Raj Bhavan statement said the prepared speech contained several unsubstantiated and misleading claims while ignoring pressing issues affecting the public. It questioned official assertions about large-scale investments, stating that many memoranda of understanding had not translated into actual projects and that the state's attractiveness



to foreign investors had declined in recent years.

The Governor also linked his walkout to concerns over women's safety, pointing to a sharp rise in crimes, including cases under the POCSO Act and incidents of sexual harassment. He further flagged the growing problem of narcotics and substance abuse among youth, alleging that the issue was being treated casually.

Other issues highlighted included rising atrocities against Dalits, increasing cases

of sexual violence against Dalit women, and a high number of suicides reported annually in the state. The statement described the situation as alarming and said it reflected administrative neglect.

Ravi also criticised what he described as declining education standards and mismanagement of educational institutions. He noted that thousands of village panchayats remain defunct due to delayed elections, denying citizens grassroots democratic rights. In addition, he raised concerns about temples being run directly by the state without trustees and the lack of implementation of court directions. Stress faced by MSMEs and the migration of entrepreneurs to other states were also cited.

BCCI Plans Central Contract Revamp, Kohli and Rohit Likely to Move Down Grades

■ Scrapping of A+ Category Could Reshape Player Retainers and Contract Structure

New Delhi: The Board of Control for Cricket in India is considering a major restructuring of its central contract system, a move that could significantly alter how senior and emerging players are categorised and compensated. The proposed overhaul may see the elimination of the top A+ category, which has traditionally been reserved for elite all-format cricketers.

Under the new



framework, the central contract system would reportedly be streamlined into three tiers only: Grade A, Grade B and Grade C.

This proposal has been put forward by the men's selection committee led by Ajit Agarkar and is awaiting formal approval

from the BCCI's Apex Council.

If implemented, the changes would have a notable impact on some of Indian cricket's biggest names. Virat Kohli and Rohit Sharma, who have stepped away from Test cricket and T20 Internationals, are expected to be placed in Grade B. This would mark the first time in more than a decade that the two stalwarts would not feature in the top contract bracket.

Suryakumar Yadav Faces Defining Leadership Test Ahead of World Cup

■ New Zealand T20I Series Set to Challenge India Captain's Form and Authority

New Delhi: India's five match T20I series against New Zealand, beginning Wednesday, arrives at a crucial moment for captain Suryakumar Yadav, offering a final high pressure rehearsal before the team

begins its World Cup title defence in less than three weeks. While India's results under his leadership have been impressive, the upcoming series places the spotlight firmly on the skipper's personal form

and influence. Since taking over the T20 leadership in 2024, Suryakumar has guided India to a win percentage exceeding 72 percent, masking his own struggles with the bat for a significant period.



However, with expectations soaring at home and the prospect of becoming the first team to successfully defend a World Cup title, his lack of runs has become a growing concern.

"I Thought It Was Enough": Saina Nehwal Bids Farewell to Competitive Badminton

■ Olympic Medallist Ends Storied Career After Prolonged Battle With Chronic Knee Injury

New Delhi: Indian badminton icon Saina Nehwal has confirmed her retirement from competitive badminton, bringing an end to a remarkable career that helped redefine the sport in the country. The former world number one has been away from competitive action for nearly two years, largely due to a chronic knee condition that gradually made elite-level training and competition impossible.

Saina last appeared in a professional match at the Singapore Open in 2023 but chose not to make a formal retirement announcement at the time. She explained that her decision to step away felt natural and personal, shaped by her physical limitations rather than by any specific moment or event. In her view, the absence from tournaments was itself a clear indication that her competitive journey had reached its conclusion.

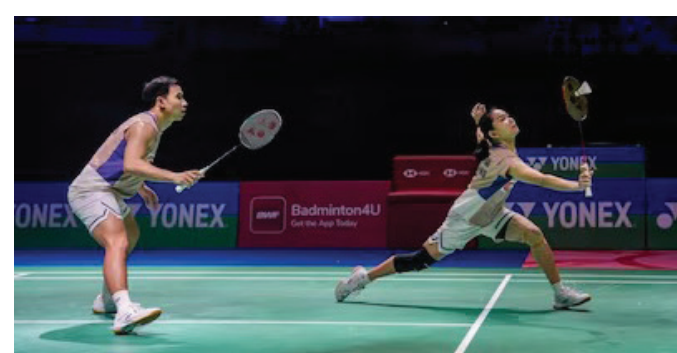
The 2012 London Olympic bronze medallist revealed that severe cartilage degeneration and arthritis in her knees



played a decisive role in forcing her hand. The condition severely restricted her ability to endure the intense training schedules required to compete at the highest level. While elite badminton demands eight to nine hours of daily training, she found herself unable to train beyond one or two hours before pain and swelling set in.

Saina said she eventually reached a point where continuing no longer felt possible or sensible. With her body no longer responding as it once did, she felt it was time to stop pushing beyond her limits. The decision, though difficult, was one she described as unavoidable.

Her career had already been altered significantly by a serious knee injury sustained during the Rio 2016 Olympic Games.



Sports Ministry Orders SAI to Address India Open Lapses After International Backlash

■ Concerns Raised Over Venue Management, Player Safety Ahead of 2036 Olympic Bid

New Delhi: Following widespread criticism over organizational lapses at the India Open last week, the Sports Ministry has directed the Sports Authority of India (SAI) to implement corrective measures, according to reports. Sports Minister Mansukh Mandaviya convened a meeting with SAI officials on Monday to review the issues and demand a detailed action

plan. The tournament faced numerous disruptions that drew complaints from overseas players and sparked concerns about India's ability to host international events smoothly. Problems highlighted included bird droppings on the court, a monkey entering the spectator stands, and poorly maintained facilities such as washrooms and practice areas.

Sparkling Stars Shine in Finale to Secure Back-to-Back UBL Titles

PANAJI: Sparkling Stars successfully defended their Ultimate Badminton League crown with a commanding 150-132 victory over Asher's Smashers in the grand finale of UBL Edition 6.0, held at the Indoor Stadium in Campal.
