



CM, BJP MLAs Slam MP Viriato Over Dabolim Claims Say Airport Will Not Shut

| Challenge Him to Prove 'Confidential' Allegation.

Panaji: Chief Minister Pramod Sawant and BJP MLAs on Thursday strongly refuted claims regarding the future of Dabolim Airport, accusing South Goa MP Captain Viriato Fernandes of making baseless allegations for



political mileage ahead of elections.

With elections nearing, the Chief Minister said

the Opposition was attempting to manufacture issues. "Elections cannot be fought over Dabolim

Airport alone," Sawant said, accusing the MP of making statements outside Parliament to gain "weightage."

"Dabolim Airport will never be shut down. That is my clear statement," the CM asserted, reiterating the assurance given on the floor of the House.

Echoing similar




sentiments, MLA Sankalp Amonkar accused MP Viriato of misleading the public. "He has a habit of misleading the people. On every issue, he is misleading the public," Amonkar said. He



maintained that Dabolim Airport would neither be closed nor handed over to the Navy.

Pakistan Protests Over India's Map Showing PoK as Part of Indian Territory

■ Islamabad raises objection with New Delhi after map depiction of Pakistan-occupied Kashmir sparks diplomatic concern

Islamabad: Pakistan has lodged a formal protest with India over the way Pakistan-occupied Kashmir was shown on an Indian map, saying the depiction of the region as part of Indian territory is unacceptable and demands clarification. Officials in Islamabad conveyed strong objections through diplomatic channels, calling the representation inconsistent with

international norms and saying it undermines Pakistan's position on the disputed territory.

According to Pakistan's foreign office, the matter was raised directly with Indian diplomatic representatives, with Islamabad asserting that the map projection could have serious implications for bilateral relations. The Pakistani side demanded that India explain the

THIVIM: Revolutionary Goans Party (RGP) chief Manoj Parab has alleged irregularities in the functioning of the Thivim panchayat, claiming that it is being controlled not by the BJP but by former MLA Kiran Kandolkar.

Addressing the media, Parab accused the panchayat secretary and members of granting



permission to a mega project without conducting a mandatory site

inspection. He termed the move as fraudulent

and demanded that the approval be immediately revoked.

Parab further stated that local villagers are strongly opposing the proposed project and warned that the RGP would support residents in their protest if corrective action is not taken.

He urged authorities to intervene and ensure transparency in the decision-making process.

India's Biggest Defence Purchase Moves Forward as 114-Rafale Deal Clears Key Hurdle

■ Clearance paves way for contract talks, production timelines and major boost to Indian Air Force combat strength

New Delhi: India's largest-ever military procurement has crossed a major milestone with a crucial clearance for the purchase of 114 Rafale fighter jets for the Indian Air Force. The development marks a significant step forward in strengthening the country's air power and

modernising its fighter fleet.

The clearance removes an important procedural bottleneck in the long-pending programme and opens the door for formal commercial negotiations. The proposed acquisition involves a new fleet of Rafale jets, customised



to Indian Air Force requirements, and is

expected to significantly enhance operational capability and readiness. Officials said the decision follows detailed assessments of the Air Force's long-term needs, especially in the context of shrinking squadron strength and evolving regional security challenges. The Rafale aircraft, already inducted

into the IAF in earlier tranches, is seen as a critical platform due to its advanced avionics, multi-role capability and proven performance.

With this hurdle cleared, the focus will now shift to finalising contract terms, delivery

Dabolim Again: Will Goa Get Clarity or Just Another Political Drama?

The controversy over Dabolim Airport has returned, louder and sharper, exposing once again how Goa's critical infrastructure is trapped between political posturing, strategic interests, and public anxiety. What should have been a settled question by now has instead become a recurring political storm: is Dabolim here to stay, or is it being quietly edged out in favour of Mopa? The latest trigger is the Goa Forward Party's threat of a statewide agitation if Chief Minister Pramod Sawant and Transport Minister Mauvin Godinho fail to clarify their stand on Dabolim's future. GFP chief Vijai Sardesai has escalated the issue by alleging that the push to shut down Dabolim is not coming from private airport operator GMR, but from the Union Defence Ministry itself. He has accused Godinho of failing to protect the airport and demanded his resignation.

At the heart of the debate lies a familiar pattern. Political leaders trade allegations, make counterclaims, and draw red lines, but stop short of offering Goans what they want most: a clear, written, unambiguous assurance on the future of civil operations at Dabolim.

Sardesai's claims, including references to internal file notings and post-operation military plans, have added a sense of urgency and unease. Whether these allegations are fully accurate or politically amplified is beside the point. What matters is that they resonate with a long-standing fear among South Goa residents that Dabolim, once Goa's only gateway, is being slowly sacrificed. Leader of Opposition Yuri Alemao has echoed these concerns, pointing out the absence of a categorical assurance from the Defence Minister. His warning that "something is fishy" reflects a broader sentiment: that behind the official language of coordination and dual-airport models, decisions may already be drifting in a direction the public has not been told about.

On the other side, Mauvin

Godinho and MLA Jit Arolkar insist that both Dabolim and Mopa will function together, complementing each other. The dual-airport narrative is appealing on paper. Goa's tourism economy needs connectivity. Charter traffic, domestic flights, international arrivals, and regional routes cannot all be funnelled through one airport without consequences. But this argument loses credibility when it is not backed by formal guarantees. Verbal assurances, press statements, and political rebuttals do little to reassure airlines, tourism stakeholders, or ordinary Goans who depend on Dabolim for accessibility and livelihoods.

Dabolim is not just an airport. It is symbolic. It represents South Goa's economic link to the rest of the country, a lifeline for local businesses, taxi operators, airport workers, and residents. Its status as a civil enclave under Navy control has always required delicate coordination. That reality demands transparency, not ambiguity.

The operationalisation of Mopa has intensified these anxieties. While Mopa promises growth and modern infrastructure, its emergence should not automatically mean decline elsewhere. Goa's geography, tourism patterns, and seasonal traffic justify more than one functioning airport. The idea that development must come at the cost of displacement is neither inevitable nor acceptable.

What is striking is how political responsibility keeps shifting. State ministers point to the Centre. Opposition leaders accuse the state of complicity. The Centre remains largely silent. In this vacuum, speculation thrives.

If Dabolim is secure, the government should say so plainly, with a written assurance from the Defence Ministry confirming the continuation of civil operations. If changes are being considered, Goans deserve honesty, not reassurances wrapped in political language. The question is no longer about who is shouting louder. It is about governance. Infrastructure planning cannot be hostage to election cycles or factional battles. Nor should strategic considerations be used as a convenient excuse to avoid public accountability. Goa has heard this story before. Each time, tempers flare, protests loom, and then the issue fades without resolution. Until the government breaks this cycle with clarity and commitment, the suspicion will remain that Dabolim's future is being negotiated quietly, away from public scrutiny. The altar of politics has claimed many institutions. Goa cannot afford to let its airport be one more.

Why Do Politicians Always Seem to Get Away?

The recent acquittal of Goa Minister Atanasio "Babush" Monserrate in a decade-old rape case has reignited a familiar and disturbing question: why do powerful politicians appear to evade accountability for serious crimes? The case, which stretched over more than ten years, involved allegations that a minor was sexually assaulted by a sitting lawmaker. Yet, despite the gravity of the charges and the length of the trial, the outcome has left many in the public disillusioned. The court found that the prosecution failed to prove key elements of the offence, but the fact that such a case could linger for a decade without a conclusive resolution raises broader concerns about how our justice system functions when the accused holds political power. This is not an isolated incident. Across India, high-profile cases involving politicians often seem to end in acquittals or prolonged delays. Even when evidence is strong or public outrage is intense, trials drag on for years, witnesses become unavailable, memories fade, and momentum dissipates. Meanwhile, the accused not only remain in public life, they often thrive politically. Such patterns erode public trust. Ordinary citizens see a double standard: politicians enjoy the benefits of position while victims and their families grapple with uncertainty and injustice. If the rule of law is to mean anything, it must apply equally to all, regardless of wealth, influence or vote bank appeal. Goans deserve better. We need a justice system and political culture that holds everyone to the same standard without fear or favour.

When Power Washes Away Accountability

The acquittal of Goa Minister Atanasio "Babush" Monserrate in a rape case involving a minor has left many Goans with an unsettling feeling that justice in this country operates on two tracks. One for the ordinary citizen, and another for those who enjoy political protection. What troubles people is not only the verdict, but the pattern it fits into. Serious charges are followed by prolonged trials, missing links, weak prosecution, and finally an acquittal that is legally sound but morally hollow. By the time the case ends, public memory fades and political careers remain intact. The popular phrase "washing machine politics" exists for a reason. Allegations that once made leaders untouchable suddenly lose their weight once they cross into the ruling establishment. While no court can convict on suspicion alone, citizens are entitled to ask why investigations into powerful individuals so often appear incomplete or poorly pursued. In cases involving sexual crimes against minors, the standard of investigation should be uncompromising. If key evidence was not collected, documented, or presented effectively, that failure cannot be brushed aside as routine inefficiency. Such lapses demand accountability, not silence. The police and prosecution carry a heavy responsibility. When investigations appear weak or selective, the damage goes far beyond one case. It tells victims that power matters more than truth, and it tells the public that justice can be negotiated. This is not about presuming guilt. It is about demanding transparency and institutional honesty. If democracy is to retain credibility, political influence must stop acting as an invisible shield. Otherwise, acquittals may close cases in court, but they will never close them in the public conscience.

Dabolim airport will not shut down: Min Mauvin to Taxi Operators

DABOLIM: The Black and Yellow United Taxi Association of Dabolim Airport met Transport Minister Mauvin Godinho at his office on Thursday to thank him for his continued support towards the functioning of Dabolim Airport, even as fresh political claims over its future triggered a strong rebuttal from the minister. Responding to recent remarks by MLA Vijai Sardesai, Godinho dismissed rumours that the airport would be shut down and handed over entirely to the defence forces.

“Everyone is aware



of the rumours that Dabolim Airport will be shut and taken over by the defence. I personally travelled to Delhi along with Chief Minister Dr Pramod Sawant, MLA Nilesh Cabral and Rajya Sabha MP Sadanand Shet Tanavade and met Union Defence Minister Rajnath Singh. He gave us a clear assurance that Dabolim Airport will never shut

down,” Godinho said. He added that a follow-up meeting was also held recently. “A few days ago, I again met the Defence Minister along with MP Sadanand Shet Tanavade and submitted a detailed memorandum explaining why this airport must continue permanently, and how tourism and the State’s economy would suffer if it is closed. Once again, he assured us that Dabolim Airport will not be closed,” he stated. Godinho, however, alleged that there was pressure being exerted from other quarters. “From the other side, I hear that GMR, which operates Manohar International

Airport at Mopa, is putting tremendous pressure and lobbying with the Navy to take over Dabolim Airport. That is why I requested the Chief Minister to once again meet the Union Defence Minister so that the assurance comes directly from the Centre. Despite repeated assurances from me and the Chief Minister, people continue to live in fear,” he said. Taking on Sardesai’s demand for his resignation, Godinho said, “Vijai Sardesai is in the Opposition and may want to play politics. I was the one who first informed the media that GMR was lobbying against Dabolim Airport.

Govt Tightens Rules to Prevent Diversion of Tribal Sub-Plan Funds

Panaji: In a decisive step aimed at safeguarding Tribal Sub-Plan (TSP) funds, the State government has issued fresh directives mandating strict compliance with NITI Aayog guidelines to ensure that allocations directly benefit Scheduled Tribe (ST) communities.

All line departments have now been instructed to seek prior approval from the Tribal Welfare Department before

proposing any new scheme, modification, project, or development work under the TSP. The approval must be obtained before administrative and financial sanctions are granted. The move follows concerns that certain TSP allocations were not aligned with NITI Aayog’s clarification that only plan or scheme-based expenditure should be considered while earmarking funds in proportion to the ST population.

Non-plan spending, including establishment or routine sectoral expenses, cannot be counted under TSP allocations.



Fraudulent Land Deals In Anjuna: ED Books Mohammed Suhail Under PMLA

PANAJI: The Directorate of Enforcement (ED) has filed a Prosecution Complaint under the Prevention of Money Laundering Act (PMLA), 2002 against Mohammed Suhail and his wife, Anjum Shaikh, in connection with alleged fraudulent land transactions in Anjuna, Bardez, Goa. The North Goa Principal District and Sessions Court took cognizance of the case on 2 January 2026.

ED’s investigation, triggered by a Goa Police



Special Investigation Team (SIT) charge sheet, revealed that Suhail, a known offender in land-grabbing cases, allegedly forged documents to create a fictitious person named “Malwin G. Lobo.” Using fake birth and death certificates, a fraudulent Power of Attorney was

executed to transfer the property first to Suhail’s wife in 2010, and later to a third party, Shaikh Salim, in 2011. Investigators said the property was significantly undervalued, and cash transactions above the registered value were allegedly used for personal gain. Suhail was

arrested by ED on 22 September 2025 and after completing 14 days of ED custody, was remanded to judicial custody at Central Jail, Colvale, where he remains. During the first court hearing, he appeared via video conferencing, while his wife was represented by legal counsel.


ED has stated that further investigation is ongoing to uncover the full extent of the alleged money laundering and fraudulent land dealings.

ED Attaches Properties Worth Rs 1.17 Crore In UCO Bank Gold Loan Fraud Case

PANAJI: The Directorate of Enforcement (ED), Panaji Zonal Office, has provisionally attached movable and immovable assets valued at approximately Rs 1.17 crore in connection with a bank fraud case against UCO Bank under the Prevention of Money Laundering Act (PMLA), 2002.

The investigation stems from FIR No. 09/2022, registered on 7 October 2022 by the Economic Offences Cell, Goa Police, against



Hemant Raikar and Gundu Kelvekar. The accused are alleged to have conspired to defraud UCO Bank by fraudulently securing gold loans from the Verna, Fatora, and Margao branches. During searches conducted on 5 September 2025 at the

residential and business premises of the accused, ED seized incriminating material. Investigation revealed that Kelvekar obtained 32 gold loans in the names of 20 individuals using fake gold ornaments, while Raikar, acting as the empanelled gold valuer, certified the fake gold as genuine. Loan proceeds were reportedly diverted to Kelvekar’s personal accounts and used to purchase bullion and immovable assets. The total proceeds of crime have been quantified at approximately Rs 2.81

crore. The attached properties include a benami commercial shop (Shop No. D-12, Pancharatna Building Complex, Margao), bank balance in Mrs. Mayuri Kelvekar’s account, and the value of gold assets held with Narayan Sheshgiri Jewellers. These assets have been attached as they constitute proceeds of crime or equivalent value. ED continues its investigation to unravel the full extent of the fraud and trace additional assets.

Over 280 Hectares of Forest Land in Goa Diverted for Development Projects Since 2021

PANAJI: More than 280 hectares of forest land in Goa have been cleared or diverted for non-forest uses between April 2021 and March 2025, according to official data presented in the Rajya Sabha. Union Minister of State for Environment, Forest and Climate Change Kirti Vardhan Singh told Parliament that the land diversion covered 35 development projects, including an airport, road widening schemes, power substations, transmission lines, and the Kulem-Madgaon railway double-tracking project. The total diverted area during this four-year period amounts to 280.65 hectares, with the highest clearance recorded in 2023-24 at 178.19 hectares. In comparison, 97.65 hectares were diverted in 2020-21, while 15.6

hectares were cleared specifically for the railway project. For the current fiscal year, approvals for forest land diversion have already been granted for 13 government and private initiatives. Several of these projects are located in ecologically sensitive areas, including the proposed widening of a 53-metre stretch of the Goa-Belagavi highway, which would require felling 7,774 trees as it passes through the eco-sensitive zone of the Bhagwan Mahaveer Wildlife Sanctuary.

To mitigate environmental impact, the State Forest Department plans to implement compensatory afforestation (CA) over 487.98 hectares in three phases. This year, plantations will cover 130 hectares, followed by 178.49 hectares each in 2026-27 and 2027-28.

Man Poses As Pollution Control Board Official, Cheats Club Owner Of Rs 14.23 Lakh In Vagator

■ Anjuna Police Register Offence; Accused Allegedly Took Money For Fake PCB Licence Renewal.

ANJUNA: Anjuna Police have registered an offence against an unidentified person for allegedly impersonating an official of the Goa Pollution Control Board and cheating a Vagator-based businessman of over Rs 14 lakh.

According to police information, the complaint was lodged on February 11, 2026, at 7.25 pm by

Himanshu Malhotra (34), resident of Villa D, Umravi Villas, Vagator, Bardez-Goa, and originally from Dwarka, Delhi.

In his

complaint, Malhotra stated that on December 16, 2025, at around 1 pm in Vagator-Anjuna, Bardez, the accused, identified as Suraj Pendse (full details

not known), allegedly impersonated himself as an official of the Goa Pollution Control Board.

The accused allegedly dishonestly induced the complainant by making false representations and assurances regarding the upgradation and renewal of the Pollution Control Board licence of

Club Goya. Believing the claims to be genuine, the complainant transferred a total amount of Rs 14,23,200 through multiple transactions.

Police said the accused thereby cheated the complainant of the said amount.

An offence has been registered at Anjuna Police Station, and further investigation is being carried out by PSI Sahil Warang.



Business Rivalry Turns Ugly; Man Booked for Threatening, Extortion Bid in Guirim.

■ Saligao Police Register Offence After Complaint Over Phone Threats and Rs 50,000 Demand.

SALIGAO: Saligao Police have registered an offence against a Bardez resident for allegedly threatening and attempting to extort money from a Guirim-based businessman over a business rivalry dispute.

According to police sources, the complaint was lodged by Ganesh Nagvekar, a resident of Sonar Villa, St. Anthony Waddo, Sonar Bhatt, Guirim, Bardez. In his complaint, Nagvekar stated that on January 17, 2026, he received a phone call at his residence during which the accused, identified as Peter D'Souza, a resident of Arpora-Nagao, Bardez,

allegedly issued threats with dire consequences.

Police said the accused allegedly demanded Rs 50,000 from the complainant in connection with a business rivalry. The complainant further alleged that both he and his son were threatened over the phone and that the accused used abusive and filthy language during the conversation. Based on the complaint, Saligao Police registered an offence on February 11, 2026, and initiated further investigation into the matter. The investigation is being carried out by PSI Akshay Gaonkar of Saligao Police Station. Further inquiries are in progress.

Man duped of Rs 2.30 lakh after fraudster poses as bank officer in Vasco

VASCO: A Vasco resident was allegedly cheated of ₹2,30,948 after an unknown person posing as a bank officer induced him to download a fraudulent mobile application. According to the complaint lodged by

Mahadev Tadel, a resident of Mundvel, Vasco, the incident occurred on 07/02/2026 at 01.28 hrs. The complainant stated that he received a call from an unknown person who impersonated himself as a bank official and convinced him to download an application

by sending an APK file, claiming that it would make banking transactions easier. After downloading the file, an amount of ₹2,30,948 was allegedly fraudulently debited from the complainant's bank account. Vasco police have registered an offence

under Section 319(2) of the Bharatiya Nyaya Sanhita (BNS). Further investigation is being carried out by PSI Mayur Sawant of Vasco Police Station under the supervision of PI Vaibhav Naik and the guidance of Mormugao DySP Gurudas Kadam.

Seven booked for constructing illegal wall on public road at Arossim

AROSSIM: An alleged attempt to block the access road leading to a hotel project at Arossim by constructing an illegal wall on a public road has led to the registration of an offence by Verna police. As per the complaint filed by Bernard Dias, a resident of Arossim, the incident occurred

between 08/02/2026 and 10/02/2026 after 20.00 hrs. The accused persons — Jose Joaquim Ferandes, Simao D'Silva, Darick Azavedo, Macklin Rodrigues, Alex Azavedo, Benny D'Silva and some unknown individuals — allegedly formed an unlawful assembly with the common object of obstructing and blocking the access road to the

complainant's hotel project. The complaint states that the accused constructed an illegal wall on the public road, thereby causing unauthorised damage and alteration to public property. It is further alleged that when the complainant's staff and workers objected to the construction activity, the accused abused them in filthy language

and criminally intimidated them with threats of dire consequences, including threats to kill. Verna police have registered an offence under Sections 189(2), 352, 351(3) read with 190 of the Bharatiya Nyaya Sanhita (BNS) and Section 3 of the Prevention of Damage to Public Property (PDPP) Act.

One Killed As Activa Rider Without Licence Crashes Into Parked Scooter In Siolim

■ Anjuna Police Book Rider For Rash And Negligent Driving After Fatal Midnight Accident.

ANJUNA: Anjuna Police have registered an offence against a 33-year-old scooter rider following a fatal accident in Siolim in the early hours of Wednesday. According to police, the case was registered on February

12, 2026, at 3.07 pm based on a complaint filed by ASI Jitendra Raul (53) of Anjuna Police Station. Police said that on February 12, 2026, at around 1.35 am, the accused, identified as Sagar Chaudhary, was riding an Activa scooter (GA-03-AG-5890) from

Assagao towards Siolim. When he reached near Electric Pole No. LT/173/39/15 at Aframent Vaddo, Siolim, he

allegedly rode the vehicle in a rash and negligent manner and lost control. The scooter reportedly dashed into a parked Activa scooter (GA-03-AA-9450), causing the rider and his two pillion riders to fall on the road and sustain injuries. The pillion riders have

been identified as Bibek Chaudhary (22), residing at Siolim, and Prabin Chaudhary (23), residing at Assagao. All three are natives of Ward No. 8, Ghodaghodi, Kailali, Nepal.

Police stated that Bibek Chaudhary was later declared dead at

Asilo Hospital. It was further revealed that the accused rider did not possess a valid driving licence at the time of the accident. An offence has been registered, and further investigation is being carried out by LPSI Leesha Garudi of Anjuna Police Station.



AAP Alleges Police High-Handedness At Anti-Casino Meet In Panaji

■ Valmiki Naik Claims Manhandling At CCP; BJP Accused Of Shielding Mandovi Casinos.

PANAJI: The Goa unit of the Aam Aadmi Party (AAP) on Thursday accused the ruling BJP government of using police machinery to suppress dissent during an anti-casino protest in the capital city. Addressing a press conference, AAP Goa President Valmiki Naik alleged that he was manhandled and selectively targeted by police personnel while attending a meeting at the City Corporation of Panaji (CCP), where citizens had gathered to press for



the removal of casinos operating on the Mandovi River. The delegation had assembled at the CCP office following a meeting reportedly promised by Mayor Rohit Monserrate to discuss public concerns over casinos, including a proposed high-rise

vessel in the river. Naik claimed that police used force to remove him from the public meeting, alleging that the action was politically motivated. "I do not blame the police personnel for the action taken against me. However, I strongly

condemn those who hid behind the police force and demonstrated the BJP government's pressure tactics. When we came to submit our memorandum, even Monserrate did not come forward to accept it," he said. Naik further alleged that casinos operating on the Mandovi River enjoy political protection. Referring to past election promises, he claimed that Monserrate had earlier assured voters that casinos would be removed within 100 days if elected, but later joined the BJP after the Assembly results.

Dual airport model key for Goa's growth: MLA Jit Arolkar

LUCKNOW: In Lucknow, a 6-year-old boy lost his life after being struck by a car driven by a 21-year-old Class 12 student who was returning from a farewell event. The tragedy unfolded late on Friday evening when the child was crossing the road in the city's Alambagh area.

According to police, the teenager was riding in the car after attending a farewell celebration for his classmates when the incident occurred. The vehicle hit the young boy, who was critically injured and rushed to a nearby hospital. Despite efforts to save him, the child succumbed to his injuries.

Witnesses said the

impact was severe, and residents gathered at the scene as news spread. The driver was immediately taken into custody by local police, who registered a case in connection with the accident. Law enforcement officials said they are investigating the circumstances leading up to the collision, including whether speed or loss of control played a role.

Family members of the boy were distraught and demanded strict action against the driver. Neighbours and community members also expressed grief and anger over the sudden and devastating loss of a young life.

BNP Sweeps Bangladesh Election, Tarique Rahman Set to Become Prime Minister

DHAKA, Feb 13 Bangladesh's opposition Bangladesh Nationalist Party on Friday secured a decisive victory in parliamentary elections, marking its return to power after nearly two decades and clearing the way for party leader Tarique Rahman to become the country's next prime minister. The result comes as Bangladesh emerges from months of political unrest and economic strain.

Rahman, the son of former prime minister Khaleda Zia, returned to Dhaka in December after spending almost 20 years abroad. He now faces the

immediate task of restoring political stability, reviving investor confidence and rebuilding key sectors of the economy, including the vital garment industry, after prolonged turbulence following the collapse of Sheikh Hasina's government last year.

Early vote counts from local television channels

BNP was leading or had won 181 seats, Jamaat-e-Islami 61 seats and other parties seven seats. Officials said counting was still under way in several constituencies, with full official results expected within hours. While preliminary outcomes are largely clear, the commission said the formal gazette notification confirming the results could take several days. Under Bangladesh's constitution, the new government cannot be sworn in until this notification is issued, potentially delaying the formation of the next administration.
